#### **AGENDA HEADING:**

Amendment to Chapter 134 defining "small engine repair."

#### **SYNOPSIS:**

Definitions contained in Chapter 134 do not contain a specific detail of what was considered small engine repair. On January 28, 2012, the City Council referred a request to the Plan and Zoning Commission to consider a text amendment to define "small engine repair" for enforcement purposes.

FISCAL IMPACT: NONE

#### ADDITIONAL INFORMATION:

The City Council requested the Plan and Zoning Commission define "small engine repair" for the purposes of enforcement of land use. The Plan and Zoning Commission approved a definition of "small engine repair," and the Council considered the matter on March 25, 2013.

Council requested the amendment include an allowance for repairs on professional small engines. The concern being that professional tree contactors and lawn maintenance companies require the services and the definition could be seen as excluding them from seeking the service of the business. The word "home" being struck from the definition will eliminate any confusion for business owners and staff in enforcement of the ordinance.

The second concern involved the prohibition of running up and testing the small engines outside. Staff contacted several businesses currently doing small engine repair. They report that the engines are tested inside the building with the appropriate exhaust systems. Staff reports no complaints in at least the past five years with businesses violating the provision of the ordinance that prohibits outside runup or testing of engines.

The prohibition is to mitigate the impact any noise of the business to surrounding residential neighborhoods. Staff reports the current ordinance requirements are providing appropriate levels of protection and allowing outside run-up and testing is not necessary to the successful operation of a business doing such repairs.

On February 13, 2013 the Regulation and Ordinance (R&O) subcommittee of the Plan and Zoning Commission recommended that the following definition be prepared for public hearing by Plan and Zoning Commission:

Small engine means a motor used to power home tools and equipment including generators, lawnmowers and other outdoor power tools producing an average output that ranges around 25 horsepower, which is usually powered by gasoline and that varies in size, shape and compression process depending on its configuration.

The proposed definition would be added to Section 134-3 of the City Code. In addition, the list of permitted uses for the C-1, Neighborhood Retail Commercial District (Section 134-842) would be amended to specifically reference small engine repair shops.

#### II. ADDITIONAL APPLICABLE INFORMATION

Staff contacted DMACC for input regarding the proposed definition of a small engine. DMACC representatives indicated they do not have a "small engine" certification program and did not offer any changes to the proposed definition.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 134-3 to add a definition for "small engine", and by amending paragraph (vv) of subsection (2) of Section 134-842, relating to the regulation of lawn mower and small engine repair shops, as follows:

#### Sec. 134-3. Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:
