HOLD HEARING FOR CONVEYANCE OF THE VACATED NORTH/SOUTH ALLEY LYING WEST OF AND ADJOINING 3808 SW 2ND STREET TO DIANA MEYERS FOR \$75

WHEREAS, on September 16, 1996, by Roll Call No. 96-3200, City Council approved and adopted Ordinance No. 13,376 vacating the north/south alley right-of-way between SW 2nd and SW 3rd Streets and between Rose and Watrous Avenues; and
