RESOLUTION SCHEDULING PUBLIC HEARING ON THE VACATION AND LEASE OF PUBLIC RIGHT-OF-WAY FOR SIDEWALK CAFES AT 400 WALNUT STREET

The South 6.33 feet of the Walnut Street right-of-way lying North of and adjoining Lot 12, Block 21, Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

- 2. If the City Council first decides to vacate the above described right-of-way, the City of Des Moines proposes to lease such vacated right-of-way to The Gramercy Tap LLC (Mike Hutchison) and Wasabi Tao (Chang Jie Wang) for sidewalk cafes.
- 3. The City Council shall consider the adoption of said ordinance and the leases of such real estate at a public hearing to be held on June 24, 2013, at 5:00 p.m., in the Council Chambers.
