APPROVAL OF THE COMMUNITY SERVICES BLOCK GRANT (CSBG) COMMUNITY ACTION PLAN (APPLICATION) FOR THE 2014 CSBG PROGRAM YEAR

WHEREAS, Des Moines Community Action Agency is charged with providing programs and services to the City's low-income families through the Community Services Block Grant (CSBG) funding. This funding assists low-income families and individuals with basic essential needs that include energy, food, and shelter. Programs and services are developed to assist families with working towards self-sufficiency;

WHEREAS, in order to continue funding local community action service programs, the City's Housing Services Department, as a Community Action Agency for the Community Services Block Grant (CSBG) Program, has prepared the City of Des Moines' FY2014 CSBG Community Action Plan and Application in the amount of \$574,996 in CSBG funds for the time period of October 1, 2013 to December 31, 2014, which Plan and Application is on file in the Clerk's Office and by this reference made a part thereof; and

WHEREAS, the CSBG Plan and Application provides a detailed description of the community services needs of the City's low-income residents and provides a comprehensive non-duplicative approach for addressing those needs; and

WHEREAS, on June 19, 2013, the Housing Services Board recommended approval of the CSBG Community Action Plan and Application;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above-referenced CSBG Community Action Plan and Application which sets out the goals, objectives, and budget of the 2014 CSBG Program Year is hereby approved and that the Mayor is hereby authorized and directed to execute the above-referenced CSBG Plan and Application and the City Manager or his designee is hereby directed to submit the Plan and Application to the Iowa Department of Human Rights, Division of Community Action Agencies.
