## APPROVING EXCEPTION TO COMPETITIVE PROCUREMENT PROCESS AND APPROVING 3 MONTH EXTENSION TO AGREEMENT WITH EMC RISK SERVICES TO PROVIDE WORKERS' COMPENSATION BILL REVIEW, BILL PAYMENT AND CLAIMS MANAGEMENT FOR THE PERIOD JULY 1, 2013 THROUGH SEPTEMBER 30, 2013

WHEREAS, EMC Risk Services, Barb A. Sullivan, President, 717 Mulberry Street, Des Moines, Iowa 50309, currently provides workers' compensation bill review, bill payment and claims management pursuant to an agreement which will expire June 30, 2013;

WHEREAS, a request for proposal (RFP) for a new agreement for these services was issued on April 22, 2013; and

WHEREAS, during the proposal evaluation process, it was determined that more data will be required before a proposal can be put forward for approval; and

WHEREAS, as described in the attached Council Communication, the proposers now have until July 3, 2013 to provide the additional data; and

WHEREAS, EMC Risk Services is willing to extend the current bill review agreement through September 30, 2013 without a rate increase in order to allow the City to complete its RFP evaluation for a new agreement; and

WHEREAS, while the 3 month extension of the EMC Risk Services agreement has not been obtained through a competitive process, Des Moines Municipal Code Subsection 2-710(b) authorizes the City Council subject to the recommendation of the City Manager, to waive the RFP process upon good cause shown; and

WHEREAS, the City Manager recommends that the above described procurement be exempted from the RFP requirements for good cause shown, pursuant to Des Moines Municipal Code Subsection 2-710(b); and
