**AGENDA HEADING:**

An ordinance to amend Chapter 114 of the Municipal Code of the City of Des Moines, Iowa, relating to residential parking during snow events.

**SYNOPSIS:**

Recommend Council approval of an amendment to Chapter 114 of the Municipal Code regarding parking restrictions during snow operations.

**FISCAL IMPACT: NONE**

**ADDITIONAL INFORMATION:**

In July 2012, Council amended Chapter 114 to restrict parking during snow events. Five (5) neighborhoods (Carpenter, Drake, Drake Park, River Bend and Sherman Hill) have a modified parking restriction allowing alternative on-street parking on odd or even days of the month coinciding with odd or even street addressing (e.g., on-street parking is allowed in front of 1211 22<sup>nd</sup> Street on the 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, etc. of each month during snow removal operations, and allowed on the 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup>, etc., on the opposite side of the street).

Following the first snow season with odd/even restrictions, the River Bend Neighborhood Association leadership requested a reduction in the size of the modified parking restriction related to their neighborhood boundary. In order to afford better, faster snow removal to a greater portion of their constituents, the River Bend Neighborhood Association requested on-street parking be completely restricted during snow removal activities for the portion of the River Bend Neighborhood east of 6<sup>th</sup> Avenue. Public Works staff is in support of this request.

A public education program will be used to inform the affected households about the change.

As discussed in the meeting between Public Works and the River Bend neighborhood held Monday July 1, 2013 regarding possible odd/even parking area reductions, observations by the neighborhood leadership last winter season revealed a majority of residents in the area east of 6th Ave do not park on the street during snow removal or have off street parking available on their property.

On Monday July 8, 2013 at the River Bend board meeting, the motion to request removal of the area in the River Bend neighborhood east of 6th Avenue from the Odd/Even parking restrictions was put to a vote. 7 board members voted in favor of allowing this area to be part of the city wide restrictions of no parking during snow events. There was one board member absent. No board members voted in opposition.

The River Bend Neighborhood requests removing the area east of 6th Avenue from the Odd/Even Parking restrictions to afford better and faster snow removal.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-4175, relating to the Zone "B" boundary description for odd/even side snow parking zones.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-4175, relating to the Zone "B" boundary description for odd/even side snow parking zones, as follows:

**Sec. 114-4175. Designated.**

The following streets and portions of streets constitute "odd/even side snow parking" zones and drivers of vehicles on streets within such odd/even side snow parking zones shall conform to the provisions of sections 114-236 and 114-236.015 of this chapter:

- (1) *Zone "A" Boundary Description.*  
The Zone "A" boundary description is as follows: beginning at a point on the west side of 42<sup>nd</sup> Street and the north side of Forest Avenue, thence east along the north side of Forest Avenue, thence northwest along the southwest side of Beaver Avenue, thence northeast along the northwest side of Witmer Parkway, thence north along the west side of 34<sup>th</sup> Street, thence east along the north side of Jefferson, thence north along the west side of 30<sup>th</sup> Street, thence east along the north side of Franklin Avenue and an extension of the north side of Franklin Avenue, thence north along the west side of 23<sup>rd</sup> Street, thence east along the south side of Lincoln Avenue, thence south along the east side of Martin Luther King Jr Parkway, thence west along the north side of Interstate 235, thence north along the west side of 42<sup>nd</sup> Street to the point of beginning.
- (2) *Zone "B" Boundary Description.*  
The Zone "B" boundary description is as follows: beginning at a point on the west side of 9<sup>th</sup> Street and the north side of University, thence north along the west

side of 9<sup>th</sup> Street, thence east along the north side of Hickman Road and ~~continuing along the north side of Arlington Avenue, thence east along the north side of Franklin Avenue,~~ thence south along the east side of ~~2<sup>nd</sup> Avenue~~ 6<sup>th</sup> Avenue, thence west along the north side of University Avenue to the point of beginning.

(3) Zone "C" Boundary Description.

The Zone "C" boundary description is as follows: beginning at a point on the west side of Martin Luther King Jr Parkway and the north side of Ingersoll Avenue, thence north along the west side of Martin Luther King Jr Parkway, thence east along the south side of Interstate 235, thence south along the east side of 15<sup>th</sup> Street, thence west along the north side of Ingersoll Avenue to the point of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
