RESOLUTION APPROVING APPLICATION TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY FOR ENTERPRISE ZONE BENEFITS FOR THE MELBOURNE IV, LLC, PROJECT IN THE SE 14TH STREET ENTERPRISE ZONE

WHEREAS, on September 14, 1998 By Roll Call No. 98-2603, the City Council established the Des Moines Enterprise Zone Commission ("Commission") and on October 28, 2008 by Roll Call No. 08-1912 the City Council approved the SE 14th Street Enterprise Zone, all of which the State of Iowa subsequently certified, pursuant to Iowa Code §§15E.194 and 15E.195; and,

WHEREAS, Melbourne IV, LLC (the "Developer"), requests approval of its application for enterprise zone benefits for the construction of 72 housing units in the SE 14th Street Enterprise Zone involving a total investment of approximately \$7.9 million; and,

WHEREAS, the Developer's application appears to meet all of the requirements for enterprise zone benefits; and

WHEREAS, Council is requested to recommend approval of the Developer's application for Enterprise Zone benefits to the Commission as well as the Iowa Economic Development Authority ("IEDA"), which administers the State of Iowa Enterprise Zone Tax Credits.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The application describing how the Melbourne IV, LLC, project meets the requirements for enterprise zone benefits, herein referenced as Exhibit "A" is accepted.
- 2. The Melbourne IV, LLC, application is recommended for approval to the Des Moines Enterprise Zone Commission and the IEDA.
- 3. The Office of Economic Development is directed to transmit a copy of this Roll Call to the Commission and to IEDA and to conduct project compliance monitoring.
- 4. Upon IEDA approval of the application, the Mayor is authorized to execute and the City Clerk is directed to attest to his signature on any documents necessary for the Melbourne IV, LLC project to receive enterprise zone benefits.
