RESOLUTION TO APPROVE THE SECOND AMENDMENT TO THE LEASE AGREEMENT WITH DES MOINES DAYCARE, L.L.C. OF CITY-OWNED PROPERTY IN THE UPPER LEVEL OF THE 5th AND KEO WAY PARKING GARAGE

WHEREAS, on June 11, 2012, by Roll Call No. 12-0926, the City of Des Moines as landlord and Des Moines Daycare, L.L.C. as lessee entered into a Lease Agreement for the purpose of lessee's operation of its Des Moines Daycare Center business within the City-owned upper level of the 5th and Keo parking garage (hereinafter "Leased Premises"); and

WHEREAS, on June 5, 2013, under authority granted by Roll Call No. 12-0926, the City's Real Estate Division Manager and Des Moines Daycare, L.L.C. negotiated and signed the First Amendment to Lease Agreement as requested by Des Moines Daycare, L.L.C., to make minor, unsubstantial changes to the original agreement, including (1) replacing one of the L.L.C. Members and Individual Guarantors, (2) changing the rent payment due date from the 1st of the month to the 15th, and (3) setting up a repayment plan for past due rent; and

WHEREAS, Des Moines Daycare, L.L.C. has now requested that the size of the Leased Premises be reduced from 20,530 square feet to 9,944 square feet, or to 48% of the square footage set forth in the Lease Agreement, for the remainder of the lease term; and

WHEREAS, Des Moines Daycare, L.L.C. and City staff have negotiated that the above reduction in square feet for the Leased Premises will result in a proportionate reduction to the rent payment from \$5,133 per month to \$2,464 per month, beginning on December 15, 2013 and thereafter for the duration of the Lease Agreement, and that the Lease Agreement be further amended to allow for termination by the City with or without cause upon 30 days' notice, with no other changes to the Lease Agreement as amended by the First Amendment thereto.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the Second Amendment to Lease Agreement between the City and Des Moines Daycare, L.L.C., on file in the office of the City Clerk, reducing the total square footage of the Leased Premises from 20,530 square feet to 9,944 square feet and the rental consideration paid by Des Moines Daycare, L.L.C. from \$5,133 per month to \$2,464 per month, and allowing for 30-day notice of lease termination by the City with or without cause, is hereby approved.
- 2. In accordance with the Second Amendment to Lease Agreement, the Leased Premises as amended shall be legally described as follows:
 - 9,944 square feet on the top floor of the north end of the 5th & Keo Way parking garage located north of and adjoining the real property locally known as 555 5th Avenue, Des Moines, Iowa, which area is legally described as follows:
