

SCORES SPORTS BAR AGREEMENT


I, Julie White, owner of SCORES SPORTS BAR located at 2335 Hickman Avenue, agree and pledge to the City Council and the neighborhood in which Scores Sports Bar is located that I will continue to work with police and my neighbors to foster a safe business and clean property by either implementing or continuing the list of management items that follow:

1. I have signed a trespass letter for the Des Moines Police Department allowing police to enforce trespassing laws on the property without further request by me or my staff.
2. I currently have and will maintain both interior and exterior security cameras with recording capability to monitor the business property and parking lots 24 hrs per day.
3. I have installed and will maintain parking lot lighting.
4. I have installed trash receptacles in the parking lot.
5. I currently have hired and will maintain security personnel at my business when my business is open which is usually 7 days per week.
6. I have and will continue to instruct the security personnel as well as my regular employees to call police when they observe suspected crimes occurring.
7. I have and will continue to instruct the security personnel to monitor my parking lot and adjacent lots and call police when necessary.
8. I am a member of Prospect Park Neighborhood Association and have an open door policy to address any neighborhood concerns.
