APPROVING COMPLETION AND ACCEPTANCE OF 2012 RIVERWALK IMPROVEMENTS SUBJECT TO RECEIPT OF DOCUMENTATION

WHEREAS, on April 9, 2012, under Roll Call No. 12-0512, the City Council approved an agreement between Principal Life Insurance Company (Mary O'Keefe, Chief Marketing Officer and Senior Vice President, 711 High, Des Moines, Iowa) (Principal) and the City of Des Moines (City) for the construction and funding of the 2012 Riverwalk Improvements, which includes: promenade adjacent to YMCA, floodwall and walkway between Court Avenue and the Red Bridge along Water Street and E. 1st Street (east and west), lighting between the Red Bridge and Walnut Street (east) and pedestrian crossings at Court Avenue and Walnut Street (east). In accordance with the Agreement, upon acceptance of the improvements by the City Council, the City shall be the owner of the improvements; and

WHEREAS, Principal entered into an agreement with Jensen Construction Company (Kurt Rasmussen, President and CEO, 5550 NE 22nd Street, Des Moines, Iowa) (Jensen) for construction of the improvements; and

WHEREAS, said Agreement between Principal and the City for construction and funding of 2012 Riverwalk Improvements pursuant to Roll Call No. 12-0512, dated April 9, 2012, stated that the City shall by resolution of the City Council accept ownership and control of the project improvements upon completion of the improvements provided that Principal submit certain documentation to the City Engineer as detailed in the City Engineer's Certification of Completion; and

WHEREAS, as of December 18, 2013, Principal has not provided the required documentation, as referenced in the City Engineer's Certification of Completion. The City Engineer recommends acceptance of the project in accordance with the Agreement approved by the City Council subject to and contingent upon the acceptance of the City Engineer of the required documentation. However, Principal has assured staff that the required certification and documentation will be provided as soon as possible and the City Engineer recommends acknowledging the completion and the acceptance of the construction of said 2012 Riverwalk Improvements subject to receipt of certification and documentation and payment for professional design and construction phase services.

CERTIFICATION OF COMPLETION:

Principal Life Insurance Company (Mary O'Keefe, Chief Marketing Officer and Senior Vice President, 711 High, Des Moines, Iowa) (Principal) and the City of Des Moines (City) entered into an Agreement for Construction and Funding of 2012 Riverwalk Improvements pursuant to Roll Call No. 12-0512, dated April 9, 2012, for the purpose of construction and funding of the 2012 Riverwalk Improvements, which includes: promenade adjacent to YMCA, floodwall and walkway between Court Avenue and the Red Bridge along Water Street and E. 1st Street (east and west), lighting between the Red Bridge and Walnut Street (east) and pedestrian crossings at Court Avenue and Walnut Street (east). Said Agreement between Principal and the City for construction and funding of 2012 Riverwalk Improvements pursuant to Roll Call No. 12-0512, dated April 9, 2012, stated that the City shall by resolution of the City Council accept ownership and control of the project improvements provided that:

- 1. Principal shall have provided certification and documentation to the City Engineer that its contractor and all subcontractors and suppliers for design and construction of the project improvements have been paid in full.
- 2. The City Engineer finds and concludes and reports to City Council that [a] that the Project has been completed and constructed in substantial conformance with the plans and specifications, design documents and contract documents, and [b] that Principal and its contractor have performed all of their respective obligations as provided in said Agreement.

I hereby certify that the construction of said 2012 Riverwalk Improvements described as promenade adjacent

to YMCA, floodwall and walkway between Court Avenue and the Red Bridge along Water Street and E. 1st Street (east and west), lighting between the Red Bridge and Walnut Street (east) and pedestrian crossings at Court Avenue and Walnut Street (east); all in accordance with the contract documents including Plan File Nos. 544-67/195, Activity ID 11-2012-001 has been completed in substantial compliance with the plans and specifications approved on April 27, 2012 in accordance with the Agreement, design documents and contract documents.
