**AGENDA HEADING:**

Approving amendment to Chapter 70 Article III. OFFENSES AGAINST PUBLIC SAFETY with regard to implementation of fees for hunting permits.

**SYNOPSIS:**

Recommend approval of proposed changes to the Municipal Code Chapter 70, including:

Article III. OFFENSES AGAINST PUBLIC SAFETY Sec. 70-84. Hunting.

**FISCAL IMPACT:**

Amount: \$1,000-\$1,500 projected additional calendar year 2014 revenue based on historical data.

Funding Source: Horticulture Maintenance, GE001 PKS070400, page 172.

**ADDITIONAL INFORMATION:**

On November 26, 2013, by Resolution Number 13-093, the Des Moines Park and Recreation Board received and filed Chapter 70 recommended proposed fees. On December 16, 2013, by Resolution Number 13-101, the Des Moines Park and Recreation Board unanimously approved (14-0 with one (1) board member absent) the below recommended fee.

Staff has reviewed sections of Chapter 70 of the Municipal Code in regard to implementing fees for hunting permits, which are allowed in the Code section titled Offenses Against Public Safety. The proposed hunting permit fee reflects the cost of staff's time associated with issuance of permits.

*Section 70-84. Hunting*

Managing the urban bow hunt program requires a significant amount of time for staff oversight and administration. To offset some of this expense, staff is recommending implementation of a permit fee of \$10 for applications completed on or before August 31, and a fee of \$20 after that date.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 70-84(b)(4), relating to hunting permit application fees.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 70-84(b)(4) relating to hunting permits, as follows:

**Sec. 70-84. Hunting.**

-----  
(b) Licensed bow hunters meeting the requirements established by the state department of natural resources (DNR) may hunt antlerless deer within the areas designated as the "Des Moines Special Deer Management Zones" on public or private property, under all the following conditions:  
-----

(4) Hunters must have a permit issued by the director of the park and recreation department and comply with the terms and conditions of such permit. A permit application fee of \$10 shall be paid by hunters to the park and recreation department from August 1-31. The application fee shall be \$20 for applications received after August 31<sup>st</sup> during the current deer hunting season.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
