## APPROVAL OF CONVEYANCE OF 1721 CARPENTER AVENUE, CITY-OWNED MUNICIPAL HOUSING AGENCY PROPERTY, PURSUANT TO AFFORDABLE HOME OWNERSHIP PROGRAM

WHEREAS, the City of Des Moines, as Municipal Housing Agency, is a participant in the Section 5(h) Affordable Home Ownership Program, which was approved on May 30, 2000, by the United States Department of Housing and Urban Development (HUD) in which single family homes are sold to eligible residents; and

WHEREAS, on October 21, 2013, by Roll Call No. 13-1608, the Municipal Housing Governing Board approved conveyance of 1721 Carpenter Avenue to Ton Thanh Nguyen, eligible buyer; and

WHEREAS, following said approval, Mr. Nguyen requested to add his spouse, Giang Thi Kim Tran, as an eligible buyer and Program participant, and City staff have received lender preapproval allowing for revision of the purchase agreement and related documents to add Ms. Tran thereto; and

WHEREAS, Ton Thanh Nguyen and Giang Thi Kim Tran (hereinafter collectively, "Buyer") have applied for the Affordable Home Ownership Program for the property located at 1721 Carpenter Avenue, Des Moines, Iowa (hereinafter "Property") and staff has determined that the Buyer meets all of the City's Affordable Home Ownership plan requirements and is qualified for the program; and

WHEREAS, the Property, owned by the City as Municipal Housing Agency, was appraised for \$38,000; and

WHEREAS, the Buyer has received loan approval from a lender to purchase the Property; and

WHEREAS, the City of Des Moines, Municipal Housing Agency will hold a promissory note and second mortgage against the Property in the amount of amount of \$12,540; and

WHEREAS, an amended Offer to Buy Real Estate and Acceptance, a Promissory Note, a Mortgage, Disclosure of Information on Lead Based Paint and/or Lead Based Paint Hazards, a Special Warranty Deed and Restrictive Covenant and Groundwater Hazard Statement have been prepared and are on file with the City Clerk as Exhibits "A1" through "A6" and by this reference made a part hereof; and
