SET HEARING FOR VACATION AND CONVEYANCE OF DEAD-END SEGMENT OF EAST/WEST ALLEY RIGHT-OF-WAY IN THE VICINITY OF 2125 HIGH STREET TO FREEDOM FINANCIAL BANK FOR \$2,400

WHEREAS, on February 24, 2014, by Roll Call No. 14-0278, the City Council received and filed a recommendation from the City Plan and Zoning Commission that a dead-end segment of east/west alley in the vicinity of 2125 High Street (“City Right-of-Way”), legally described below, be vacated subject to reservation of an easement for any existing utilities; and

WHEREAS, City staff have further determined that such vacation should be subject to reservation of an access easement for public vehicular access across the City Right-of-Way in addition to the utility easement; and

WHEREAS, Freedom Financial Bank, located at 600 Martin Luther King Jr. Parkway and adjoining the City Right-of-Way, has offered to the City of Des Moines the purchase price of \$2,400.00 for the purchase of the City Right-of-Way in order to allow for construction of a wider drive access to their drive-through teller lanes, which price reflects the fair market value of the City Right-of-Way as currently estimated by the City’s Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be sold and the City will not be inconvenienced by the sale of said City Right-of-Way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a dead-end segment of east/west alley right-of-way in the vicinity of 2125 High Street, as legally described below:

ALL THAT PART OF THE EAST/WEST ALLEY RIGHT OF WAY LYING NORTH OF AND ADJOINING LOT 6 OF PARK PLACE, AN OFFICIAL PLAT; ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APROXIMATELY 800 SQUARE FEET.

2. That if the City Council decides to vacate the above described City right-of-way, the City of Des Moines proposes to convey such vacated right-of-way, as legally described and to the grantee and for the consideration identified below, subject to reservation of easements therein:



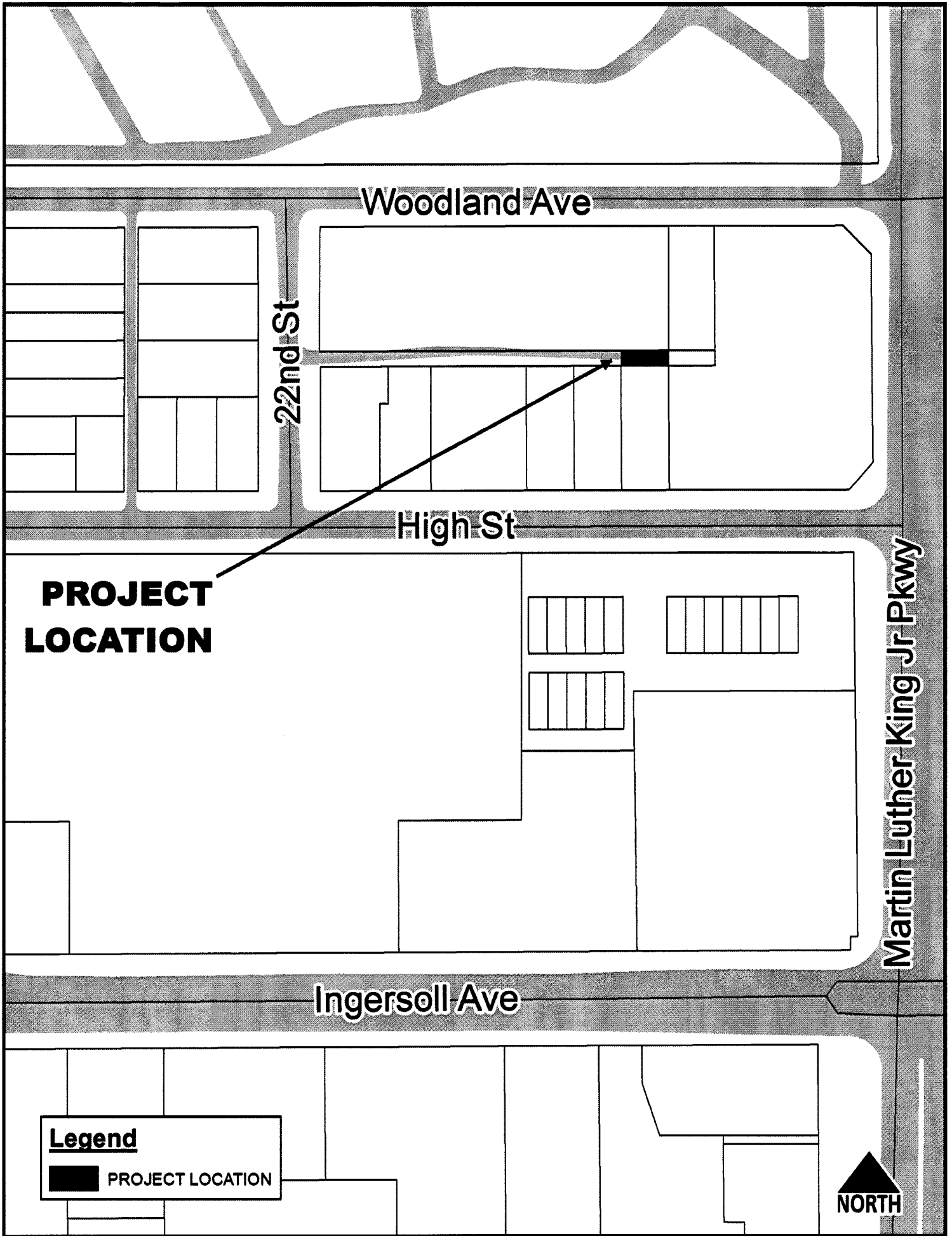
