AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2912, 114-3170, 114-3258 and 114-4013.01, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2912, 114-3170, 114-3258 and 114-4013.01, relating to traffic and vehicle regulations, as follows:

Sec. 114-2912. East Thirty-ninth Street--Four Mile Drive to East Douglas Avenue.

East Thirty-ninth Street, on the west side, from Mattern Avenue to Hull Avenue, no parking any time.

East Thirty-ninth Street, on the west side, from Four Mile Drive to East Jefferson Avenue, no parking any time.

East Thirty-ninth Street, on the east side, from Easton Boulevard to a point 100 feet south thereof, no parking any time.

East Thirty-ninth Street, on the east side, from a point 100 feet south of Easton Boulevard to a point 185 feet south thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

East Thirty-ninth Street, on the east side, from a point 285 feet south of Easton Boulevard to a point ~~185~~ 305 feet south thereof, school passenger loading and unloading 7:00 a.m. to ~~5:00~~ 4:00 p.m. school days, 30 minute limit.

East Thirty-ninth Street, on the east side, from Hull Avenue to a point 50 feet south thereof, no parking any time.

East Thirty-ninth Street, on the east side, from Glen Ellen Avenue to Richmond Avenue, no parking any time.

East Thirty-ninth Street, on the east side, from East Ovid Avenue to East Douglas Avenue, no parking any time.

Sec. 114-3170. Easton Boulevard--East Twenty-ninth Street to east city limits.

Easton Boulevard, on the north side, from East Twenty-ninth Street to East Thirty-fourth Street, no parking any time.

Easton Boulevard, on the north side, from East Thirty-fifth Street to Four Mile Creek bridge, no parking any time.

Easton Boulevard, on the south side, from East Twenty-ninth Street to East Thirty-fourth Street, no parking any time.

~~Easton Boulevard, on both sides, from East Thirty-ninth Street to East Thirty-ninth Court, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.~~

Easton Boulevard, on both sides, from 85 feet east of East Thirty-ninth Street to 90 feet east thereof, no parking any time.

Easton Boulevard, on the south side, from East Forty-second Street to a point 310 feet east thereof, no parking any time.

Sec. 114-3258. Grand Avenue--Fifteenth Street to Seventeenth Street.

Grand Avenue, on the south side, from a point 270 feet west of Fifteenth Street to a point 100 feet west thereof, no parking any time.

Grand Avenue, on the south side, from a point 370 feet west of Fifteenth Street to a point 25 feet east of Seventeenth Street, no parking 4:00 p.m. to 6:00 p.m.

Grand Avenue, on the north side, from Fifteenth Street to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the north side, from 30 feet west of Fifteenth Street to a point 70 feet west thereof, loading zone.

Grand Avenue, on the north side, from Sixteenth Street to a point 35 feet east thereof, no parking any time.

Grand Avenue, on the north side, from a point 35 feet west of Sixteenth Street to a point 25 feet east of Seventeenth Street, no parking 4:00 p.m. to 6:00 p.m.

Grand Avenue, on the north side, from Sixteenth Street to a point 35 feet east thereof, no parking any time.

Grand Avenue, on the north side, from Seventeenth Street to a point 25 feet east thereof, no parking any time.

Sec. 114-4013.01. Grand Avenue--Fifteenth Street to Sixteenth Street.

Grand Avenue, on the south side, from Fifteenth Street to a point 270 feet west of Fifteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Grand Avenue, on the north side, from a point ~~30~~ 100 feet west of Fifteenth Street to a point 35 feet east of Sixteenth Street, four-hour meters, 8:00 a.m. to ~~4:00~~ 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
