## HOLD HEARING FOR VACATION AND CONVEYANCE OF A DEAD-END SEGMENT OF EAST/WEST ALLEY RIGHT-OF-WAY IN THE VICINITY OF 2125 HIGH STREET TO FREEDOM FINANCIAL BANK FOR \$2,400

WHEREAS, on February 24, 2014, by Roll Call No. 14-0278, the City Council received and filed a recommendation from the City Plan and Zoning Commission that a dead-end segment of east/west alley in the vicinity of 2125 High Street ("City Right-of-Way"), legally described below, be vacated subject to reservation of an easement for any existing utilities; and

WHEREAS, City staff have further determined that such vacation should be subject to reservation of an access easement for public vehicular access across the City Right-of-Way in addition to the utility easement; and

WHEREAS, Freedom Financial Bank, located at 600 Martin Luther King Jr. Parkway and adjoining the City Right-of-Way, has offered to the City of Des Moines the purchase price of \$2,400.00 for the purchase of the City Right-of-Way in order to allow for construction of a wider drive access to their drive-through teller lanes, which price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be sold and the City will not be inconvenienced by the sale of said City Right-of-Way; and

**WHEREAS**, on March 24, 2014, by Roll Call No. 14-0478, it was duly resolved by the City Council that the proposed conveyance of the City Right-of-Way be set down for hearing on April 7, 2014, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey the City Right-of-Way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the alley right-of-way as described herein are hereby overruled and the hearing is closed.

2. There is no public need or benefit for the City right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of a dead-end segment of east/west alley right-of-way in the vicinity of 2125 High Street, as legally described below:

ALL THAT PART OF THE EAST/WEST ALLEY RIGHT OF WAY LYING NORTH OF AND ADJOINING LOT 6 OF PARK PLACE, AN OFFICIAL PLAT; ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APROXIMATELY 800 SQUARE FEET.

3. The proposed sale of such vacated right-of-way, as legally described below, to Freedom Financial Bank for \$2,400.00, subject to the reservation of easements therein, is hereby approved:

The Real Estate Division Manager is authorized and directed to forward the original of the Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Deed and copies of the other documents to the grantees.
