AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-611, 114-638, 114-3112, 114-3508, 114-3908, 114-3914, 114-3929 and 114-4025, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-611, 114-638, 114-3112, 114-3508, 114-3908, 114-3914, 114-3929 and 114-4025, relating to traffic and vehicle regulations, as follows:

Sec. 114-611. Bus loading zones.

- (a) When signs are erected giving notice thereof, no person shall park any vehicle, other than a bus for the purpose of loading or unloading passengers at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction.
 - (1) If days and times are indicated on the sign, bus loading and unloading is allowed only during those dates and times.
 - (2) <u>Unless posted otherwise</u>, <u>Ssuch bus shall not park for such purpose for a time exceeding 20 minutes.</u>
- (b) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-638. Parking meter and resident permit parking district no. III.

Parking meter district no. III shall be constituted of all the streets and avenues located within the area bounded by the west side of the Des Moines River, south north of Court Avenue West M.L. King Jr. Parkway; thence north to the north side of Grand Avenue; thence east to the west side of Robert D Ray Drive; thence north 700 feet; thence east to a point east of East Fifth Street, on the north side of Lyon Street; thence east to the west east side of East Twelfth Street Pennsylvania Avenue; thence south to the south side of Des Moines East Locust Street; thence west south on the east side of East Seventh Street to the east north side of Pennsylvania Avenue West M.L. King Jr. Parkway, north east of East Locust Southeast Seventh Street; thence south to the south side of East Locust Street; thence west along the north side of West M.L. King Jr. Parkway to the west side of Robert D Ray Drive; thence north to the south side of East Court Avenue; thence west to the point of beginning, except parking meter districts no. I and II as described in sections 114-636 and 114-637 of this division.

Sec. 114-3112. Court Avenue--Second Avenue to Third Street.

Court Avenue, on the south side, from Second Avenue to a point 25 feet west thereof, no parking any time.

Court Avenue, on both sides, from Third Street to a point 45 feet east thereof, no parking any time.

Court Avenue, on the north side, from Second Avenue to a point <u>115</u> <u>45</u> feet west thereof, no parking any time.

Court Avenue, on the north side, from a point 45 feet west of Second Avenue to Third Street, bus loading and unloading:

- (1) 6:00 p.m. Friday to 3:00 a.m. Saturday.
- (2) 6:00 p.m. Saturday to 3:00 a.m. Sunday.

Sec. 114-3508. Mulberry Street--Ninth Street to Tenth Street.

Mulberry Street, on the north side, from Tenth Street to a point 19 feet east thereof, no parking any time.

Mulberry Street, on the north side, from Ninth Street to a point 76 15 feet west thereofeast of Tenth Street, no parking any time.

Mulberry Street, on the north side, from a point 125 feet west of Ninth Street, to a point 15 feet west thereof, no parking any time.

Mulberry Street, on the south side, from Ninth Street to a point 145 30 feet east of Tenth Street west thereof, no parking any time.

Sec. 114-3908. Court Avenue-Second Avenue to Third Street.

Court Avenue, on the south side, from a point 25 feet west of Second Avenue to a point 45 feet east of Third Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Court Avenue, on the south side, parking meter C-216, is designated a ten-hour meter, 8:00 a.m. to 6:00 p.m., and is designated a handicapped parking space and is subject to the same prohibitions as is found in subsection 114-616(a) of this chapter.

Court Avenue, on the north side, from a point <u>45</u> feet west of Second Avenue to a point 45 feet east of Third Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-3914. Grand Avenue--Fifth Avenue to Sixth Avenue.

Grand Avenue, on the south side, from Fifth Avenue to Sixth Avenue, two-hour meters, 8:00 a.m. to 6:00 p.m.

Grand Avenue on the south side, parking meter G-510, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Grand Avenue, on the south side, parking meter G-512, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Grand Avenue, on the south side, parking meter G-520, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-3929. Mulberry Street--Ninth Street to Tenth Street.

Mulberry Street, on the north side, from a point 15 feet west of Ninth Street to a point 110 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the north side, from a point 19 feet east of Tenth Street to a point 57 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, from a point 30 feet west of Ninth Street to a point 100 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, from Tenth Street to a point 105 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4025. Locust Street--Tenth Street to Twelfth Street.

Locust Street, on the south side, from a point 30 feet west of Tenth Street to a point 110 feet west thereof, two-hour meters, 9:00 a.m. to 4:00 p.m.

Locust Street, on the south side, from a point 215 feet west of Tenth Street to a point 30 feet east of Twelfth Street, two-hour meters, 9:00 a.m. to 4:00 p.m.

Locust Street, on the north side, from a point 40 feet west of Tenth Street to a point 80 feet west thereof, two-hour meters, 6:00 a.m. to 6:00 p.m.

Locust Street, on the north side, parking meter L-1001, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Locust Street, on the north side, from a point 145 feet west of Tenth Street to Twelfth Street, two-hour meters, 6:00 a.m. to 8:00 p.m.


Locust Street, on the north side, parking meter L-1009, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.


