The City of Des Moines is processing eight liquor license applications for Dollar General and due to recent zoning code amendments, Section 134-954 of the Municipal Code of the City of Des Moines, the applications cannot be approved without Zoning Board of Adjustment conditional use permits and the pending liquor license applications must be denied.

On February 12, 2014 you were sent a communication regarding the following stores:

You were notified that all stores require a Conditional Use Permit from the Zoning Board of Adjustment, pursuant to Section 135-954 of the Municipal Code of the City of Des Moines. The applications have not been filed and the Conditional Use Permits have not been granted.

Consequently, Developmental Zoning Division of the Community Development Department is requesting the City Council deny the applications for all Dollar General Stores liquor license applications. The applications for the licenses will be heard by the Des Moines City Council on May 19, 2014. Your corporation has the right to be present and present evidence or comment during the hearing.
