RESOLUTION APPROVING APPLICATION TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY FOR ENTERPRISE ZONE BENEFITS FOR THE BROADWAY HEIGHTS III, LLC, PROJECT IN THE NE HUBBELL-BROADWAY ENTERPRISE ZONE

WHEREAS, on September 14, 1998 by Roll Call No. 98-2839, the Des Moines City Council established the Des Moines Enterprise Zone Commission ("Commission"), and on August 24, 2009 by Roll Call 09-1560, the City Council designated the NE Hubbell-Broadway Enterprise Zone, which the State of Iowa subsequently certified, pursuant to Iowa code Sections 15E.194 and 15E.195; and

WHEREAS, Broadway Heights III, LLC (the "Developer"), requests approval of its application for enterprise zone benefits for the construction of 30 housing units in the NE Hubbell-Broadway Enterprise Zone involving a total investment of approximately \$2.8 million; and

WHEREAS, the Developer's application appears to meet all of the requirements for Enterprise Zone benefits; and

WHEREAS, Council is requested to recommend approval of the Developer's application for Enterprise Zone benefits to the Commission as well as the Iowa Economic Development Authority ("IEDA"), which administers the State of Iowa Enterprise Zone Tax Credits.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The application describing how the Developer's project meets the requirements for enterprise zone benefits is accepted.
- 2. The Developer's application is recommended for approval to the Des Moines Enterprise Zone Commission and the IEDA.
- 3. The Office of Economic Development is directed to transmit a copy of this Roll Call to the Commission and to the IEDA, and to conduct project compliance monitoring.
- 4. Upon IEDA approval of the application, the Mayor is authorized to execute and the City Clerk is directed to attest to his signature on any documents necessary for the Developer's project to receive enterprise zone benefits.
