**APPROVING AND ADOPTING AN AMENDED SCHEDULE OF FEES FOR DUMPING SNOW  
UNDER CHAPTER 42 OF THE CITY CODE**

**WHEREAS**, Article VIII of Chapter 42 of the City Code, entitled "Snow Dump", provides for the regulation of depositing snow removed from residential or commercial premises and requires a permit to dump snow at the City's snow dump; and

**WHEREAS**, the Snow Dump Ordinance provides that snow dump permit fees and a nonrefundable portion to be retained as an administrative fee in the event that the permit is denied or the application is withdrawn are to be in the amounts provided in a Schedule of Fees to be adopted by the City Council by resolution; and

**WHEREAS**, by Roll Call No. 02-3007 on December 18, 2002, the City Council approved and adopted a Schedule of Fees which included snow dump permit fees; and

**WHEREAS**, the Public Works department has reviewed the costs of providing and administering the snow dump program and permit and has determined the fees be amended pursuant to the attached Schedule of Fees.

**NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA** that the Schedule of Fees appended hereto and by this reference hereto is hereby approved and adopted.

**BE IT FURTHER RESOLVED** that said Snow Dump Permit Schedule of Fees shall be maintained on file in the office of the City Clerk and the Public Works Department for public reference, and that the fees therein established shall become effective upon and as of July 15, 2014.
