PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT
DOCUMENTS, AND ENGINEER'S ESTIMATE ON
2014-2015 HMA PAVEMENT SCARIFICATION AND RESURFACING;
RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE
BIDDER AS GRIMES ASPHALT & PAVING CORP., KURT RASMUSSEN, PRESIDENT, \$365,325.50

WHEREAS, on June 9, 2014, under Roll Call No. 14-0833, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2014-2015 HMA Pavement Scarification and Resurfacing, 06-2014-008

The improvement includes scarification only of 2-inch average depth of asphalt street surfaces with specified milling machine and equipment in a cooperative effort with the City of Des Moines Public Works Department, all in accordance with the contract documents at the following locations within the City of Des Moines:

- S.E. 3rd Street (curb) from Court Avenue to Dead End South
- 4th Street from Grand Avenue to Park Street
- S.E. 6th Street from Livingston Avenue to Hillside Avenue
- 8th Street from Center Street to Crocker Avenue
- 8th Street from Washington Avenue to Franklin Avenue
- 13th Street from Forest Avenue to Clark Street
- 24th Street from University Avenue to Carpenter Avenue
- 31st Street from High Street to Center Street
- 35th Street from Crocker Street to Kingman Boulevard
- Buchanan Street from E. 9th Street to E. 12th Street
- Crescent Drive from Ingersoll Avenue to 34th Street
- Edison Avenue from S.E. 1st Street to S.E. 4th Street
- Filmore Street from Pennsylvania Avenue to E. 9th Street
- Garfield Avenue from E. 12th Street to E. 14th Street
- Garfield Avenue from E.17th Court to Stewart Street
- Germania Drive from Maquoketa Drive to 41st Street
- Glenbrook Drive from E. Jefferson Avenue to Thompson Avenue
- Henderson Avenue from E. 14th Street to E. 15th Street
- Idaho Street from Garfield Avenue to Cleveland Avenue
- Norton Avenue from 13th Street to 14th Street
- Oxford Street from E. Tiffin Avenue to E. Euclid Avenue
- Ravina Drive from Riverview Drive to Oak Park Avenue
- Riverview Drive from Oak Park Avenue to Waverly Drive
- Sampson Street from Arthur Avenue to E. Sheridan Avenue
- Stewart Street from Easton Boulevard to Cleveland Avenue
- Tonawanda Drive from 42nd Street to Tonawanda Drive N-S

Furnish all labor, materials and equipment necessary to construct a 2-inch average thickness pavement scarification and an HMA surfacing overlay of a single 2-inch lift on existing street surface, together with other incidental and related work; all in accordance with the contract documents at the following location within the City of Des Moines:

Robert D. Ray Drive from Locust Street to the Center Street Bridge

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.




