WHEREAS, Donald Stockton, who resides at 7601 NW 99th Court, in the City of Johnston, Iowa, holds an active master electrician license issued by the State of Iowa; has extensive experience being in charge of electrical installation operation at Baker Electric, Inc.; is uniquely qualified to fill the vacant Seat 7 on the Building and Fire Code Board of Appeals; and desires to serve the citizens of Des Moines in this capacity; and,

WHEREAS, Donald Stockton would be the third officer or employee of Baker Electric, Inc., to serve on the Building and Fire Code Board of Appeals, joining Chad Layland who serves in Seat 3 as a professional electrical engineer, and Gary Edgington, who serves in Seat 8 as one of two master electricians; and,

WHEREAS, Mr. Stockton and is recommended by Council Member Joe Gatto for appointment to Seat 7 on the Building and Fire Code Board of Appeals.
