WHEREAS, Fleet Maintenance requested the Finance Department Procurement Division to solicit bids for purchase of various replacement vehicles for city-wide use; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V15-002 to thirteen (13) potential bidders with three (3) bidders responding; and

WHEREAS, the low dollar compliant bid for ITEM 1 was received from Stivers Ford, 1450 E. Hickman Road, Waukee, IA 50263, Scott Politte, General Manager, at a total cost of \$26,195.00; and

WHEREAS, the second low dollar compliant bid for ITEM 1 was received from Charles Gabus Ford, 4545 Merle hay Road, Des Moines, IA 50310, Gene Gabus, President, at a total cost of \$26,199.00; and

WHEREAS, Municipal Code Sections 2-705 and 2-706 allow for preference for local goods and services, wherein preference is given to a responsive bid from a business whose headquarters is located within the corporate city limits over an acceptable low bid submitted by a business located outside of the corporate city limits, and the local bidder's bid exceeds the low bid by no more than one percent; and

WHEREAS, Charles Gabus Ford qualifies for the one percent local preference, and does not exceed the acceptable low bid by more than one percent, and thereby becomes the low dollar compliant bidder; and

WHEREAS, the low dollar compliant bid for ITEM 2 was received from Stivers Ford, 1450 E. Hickman Road, Waukee, IA 50263, Scott Politte, General Manager, at a total cost of \$39,779.00; and


WHEREAS, funding is available from CM024021/Equipment Replacement; and
