SET HEARING FOR THE VACATION AND CONVEYANCE OF THE WEST SIX (6) FEET OF SOUTHEAST 15TH STREET EAST OF AND ADJOINING 1440 MAURY STREET TO RAYMOND QUIJANO FOR \$2,330

WHEREAS, on July 28, 2014, by Roll Call No. 14-1135, City Council received a recommendation from the City Plan and Zoning Commission that the west six (6) feet of Southeast 15th Street east of and adjoining 1440 Maury Street ("City Right-of-Way"), hereinafter more fully described, be vacated subject to reservation of easements for all utilities in place until such time that they are relocated, and further subject to approval of a Site Plan by the Permit and Development Center for any commercial reuse of said right-of-way; and

WHEREAS, Raymond Quijano, owner of the adjoining property at 1440 Maury Street, has offered to the City of Des Moines the purchase price of \$2,330.00 for the vacation and purchase of the City Right-of-Way for incorporation into his adjoining property, which price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating the west six (6) feet of Southeast 15th Street east of and adjoining 1440 Maury Street, legally described as follows:

THE WEST 6 FEET OF SOUTHEAST 15TH STREET RIGHT-OF-WAY LYING EAST OF AND ADJACENT TO LOTS 61 THROUGH 64, GRAYS SUBDIVISION, BLOCKS 50 AND 62, BROOKS AND COS ADDITION, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines further proposes to sell such vacated right-of-way, as legally described below, to Raymond Quijano for \$2,330.00, subject to the requirements of the Plan and Zoning Commission recommendation:
