PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON TRAFFIC OBSERVATION CAMERA AND DOWNTOWN CMS UPGRADES; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS BAKER ELECTRIC, INC., BRITT BAKER, CEO, \$212,230.00

WHEREAS, on August 11, 2014, under Roll Call No. 14-1203, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Traffic Observation Camera and Downtown CMS Upgrades, 04-2014-004 STP-A-1945(805)--86-77

The improvement includes the removal and replacement of nine traffic observation cameras City-wide, and the installation of four Changeable Message Signs (CMS) on existing supports in the downtown area, and connecting the cameras and VMS into the City's Local Area Network primarily by using existing fiber; all in accordance with the contract documents, including Plan File Nos. 558-001/017 at thirteen locations located in the City of Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 in the amount of \$212,230.00, and said bid be and the same is hereby accepted.
