## SET HEARING FOR CONVEYANCE OF REAL PROPERTY AT 1201 CROCKER STREET TO 1201 CROCKER, LLC FOR \$160,000

WHEREAS, the City of Des Moines Municipal Housing Agency ("Housing Agency") owns the real property locally known as 1201 Crocker Street ("Property"), which is used for parking purposes associated with the Royal View Manor; and

WHEREAS, City staff have negotiated terms for conveyance of the Property from the City of Des Moines Municipal Housing Agency to the City for the purchase price of \$160,000, which price reflects the fair market value of the Property as determined by an independent appraisal, to promote economic redevelopment thereon; and

WHEREAS, 1201 Crocker, LLC has offered to the City of Des Moines the purchase price of \$160,000 for the purchase of the Property for incorporation into the adjoining property for redevelopment of a multiphase mixed use project starting with two retail buildings, which price reflects the fair market value of the Property as determined by an independent appraisal, and which offer is subject to prior approval by the Des Moines Municipal Housing Governing Board of the sale of the Property from the Housing Agency to the City and completion of said conveyance; and

**WHEREAS**, there is no known current or future public need or benefit for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, proposes to sell real property locally known as 1201 Crocker Street, as legally described below, to 1201 Crocker, LLC for \$160,000, subject to reservation of easements therein and subject to approval by the Des Moines Municipal Housing Governing Board of the sale of the Property from the Housing Agency to the City and completion of said conveyance:

LOT 6, BLOCK 7, GRASS ROOTS 1, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

- 2. A public hearing shall be held on October 6, 2014, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time, the City Council will consider the above-described proposals and any other(s) submitted prior to or during the public hearing.
