**APPROVING AN AMENDMENT TO THE SCHEDULE OF FEES

**WHEREAS**, Chapter 62 Article II section 62-43 of the Municipal Code of the City of Des Moines has been enacted to provide for fees for fair housing training to persons who live outside the Des Moines city limits in the amount set in the Schedule of Fees adopted by the City Council by resolution; and

**WHEREAS**, an amendment to the Schedule of Fees setting these fees has been prepared for Council consideration and is recommended for adoption, which amendment is appended hereto and is now on file in the office of the City Clerk;


