APPROVING AN AMENDMENT TO THE SCHEDULE OF FEES ESTABLISHING FAIR HOUSING TRAINING FEES UNDER CHAPTER 62 ARTICLE II OF THE MUNICIPAL CODE

WHEREAS, Chapter 62 Article II section 62-43 of the Municipal Code of the City of Des Moines has been enacted to provide for fees for fair housing training to persons who live outside the Des Moines city limits in the amount set in the Schedule of Fees adopted by the City Council by resolution; and

WHEREAS, an amendment to the Schedule of Fees setting these fees has been prepared for Council consideration and is recommended for adoption, which amendment is appended hereto and is now on file in the office of the City Clerk;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the amendment to the Schedule of Fees appended hereto is hereby approved and adopted.

AND BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to incorporate said amendment into the Schedule of Fees, and to maintain said Schedule of Fees, as amended, on file in the offices of the City Clerk for public reference.
