PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON
2014 SEWER REPAIR - CONTRACT 1;
RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS THE UNDERGROUND COMPANY, LTD., DUANE BURKHARDT, PRESIDENT, \$228,574.00

WHEREAS, on August 25, 2014, under Roll Call No. 14-1280, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2014 Sewer Repair - Contract 1, 08-2014-004

The improvement includes the construction of 24-inch RCP storm sewer, 59"x36" RCAP storm culvert, storm manholes, storm intake reconstruction, grading and restoration, and other incidental items; all in accordance with the contract documents including Plan File Nos. 560-175/187, located at 3015 Seneca Avenue, Forest Avenue and 2nd Avenue, and E. 29th Street and E. Aurora Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.



BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.


