HOLD HEARING FOR THE VACATION AND CONVEYANCE OF A DEAD-END SEGMENT OF EAST/WEST ALLEY RIGHT-OF-WAY EAST OF EAST 28<sup>TH</sup> STREET, BETWEEN INDIANAPOLIS AVENUE AND KINSEY AVENUE, TO RANDALL VAN GUNDY FOR \$50, TO ESTHER HALTERMAN FOR \$50, TO FAITH TABERNACLE, INC. FOR \$75, AND TO ROBERT AND BARBARA HENDERSON FOR \$100

WHEREAS, on July 28, 2014, by Roll Call No. 14-1135, City Council adopted a recommendation from the City Plan and Zoning Commission approving a request for the vacation of a dead-end segment of east/west alley between Kinsey Avenue and Indianapolis Avenue from East 28<sup>th</sup> Street to a point approximately 190 to the east, ("City Right-of-Way"), hereinafter more fully described, subject to the reservation of easements for all existing utilities in place until such time as they are relocated, and reservation of right of entry for servicing same; and

WHEREAS, Randall Van Gundy, owner of 2812 Indianapolis Avenue, Esther Halterman, owner of 2806 Indianapolis Avenue, Faith Tabernacle, Inc., owner of 2811 Kinsey Avenue, and Robert and Barbara Henderson, owners of 2800 Kinsey Avenue, have offered to the City of Des Moines the total purchase price of \$275 for the purchase of their respective portions of the vacated alley right-of-way adjoining their properties for incorporation into their adjoining property, which price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property; and

WHEREAS, on September 22, 2014, by Roll Call No. 14-1464, it was duly resolved by the City Council that the proposed vacation and conveyance of the City Right-of-Way be set down for hearing on October 6, 2014, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to vacate and convey the City Right-of-Way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the City Right-of-Way, as described herein, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of a dead-end segment of east/west alley between
