RESOLUTION AUTHORIZING PARTIAL RELEASE OF JUDGMENT LIENS (1942 ARLINGTON AVENUE)

WHEREAS, the City of Des Moines filed a lawsuit (Case No. EQCE 50919) and obtained a judgment against Eppard Investment, Inc. in the amount of \$1,395.00 in relation to nuisance abatement and enforcement costs, court costs and sanctions, which lien encumbers the real property located at 1942 Arlington Avenue, in the River Bend neighborhood in Des Moines ("Property"); and

WHEREAS, the City of Des Moines further filed lawsuits and obtained judgments against Karen Towers and Steve Towers, in relation to nuisance abatement and enforcement costs and court costs, which liens encumber the Property as follows: Case No. CICI 5816, \$825.00; Case No. CICI 5815, \$450.00; Case No. CICI 5914, \$900.00; Case No. CICI 5915, \$900.00; and

WHEREAS, on July 14, 2014, by Roll Call No. 14-1093, City Council accepted a request from Michael Hildebrand, of Hildebrand Properties, LLC, to speak regarding the Property, and referred the matter to the City Manager and the City Attorney to work with Neighborhood Finance Corporation (NFC) on recommendations regarding a policy to assist rehabilitation of nuisance properties City-wide to become owner-occupied; and

WHEREAS, as presented to Council, Hildebrand Properties, LLC has entered into a purchase agreement for the purchase of the Property from property owner 1942 Arlington Trust, for the purpose of rehabilitating and reselling the Property for owner-occupancy; and

WHEREAS, the City has been requested to release the above-listed judgment liens against the Property in order for the sale of the Property to Hildebrand Properties, LLC to proceed; and

WHEREAS, City Community Development staff have reviewed Hildebrand Properties, LLC's request and have determined that the Property is a contributing structure in the Riverview Park Plat National Register Historic District and in the River Bend Local Historic District and that it would be in the City's best interest to release the above-listed judgment liens to allow for rehabilitation and redevelopment of the Property for residential occupancy, rather than for the City to proceed with nuisance abatement and demolish the building and incur additional demolition and enforcement costs.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. The City approves partial release of its judgment liens, solely as to any liens that the City may have against the real property locally known as 1942 Arlington Avenue, Des Moines, in the following Polk County District Court cases:
