RESOLUTION RELEASING SUBDIVISION BOND FOR HILLSBORO PLAT 2 AND PROVIDING PERMANENT WAIVER OF OBLIGATION FOR DEVELOPER TO INSTALL RECREATIONAL TRAIL SEGMENT ALONG E. PINE AVENUE

WHEREAS, on January 27, 2003, by Roll Call No. 03-140, the City Council approved the subdivision plat entitled HILLSBORO PLAT 2 for land located in the vicinity of 2200 Block of E. Pine Avenue, to be developed by Jerry's Homes, Inc., represented by Ron Grubb (Officer); and,

WHEREAS, by said Roll Call, the City Council further authorized the approval and acceptance of Subdivision Bond No. IAC 33296 from Merchants Bonding Company in the amount of \$27,145 as security for the estimated cost of sidewalk improvements, recreational trail construction site erosion control and as-built survey costs; and,

WHEREAS, the required 526 lineal ft. of 10 ft. wide recreational trail along the adjacent segment of E. Pine Avenue has not been installed, and Jerry's Homes, Inc., has requested a permanent waiver of the requirement to install said trail, and;

WHEREAS, the City Engineer has certified that the required grading, site restoration, public sidewalk improvements and as-built surveys have been completed and recommends that the security be released.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council hereby finds that Jerry's Homes, Inc., should be released from the obligation to construct the segment of recreational trail adjoining Hillsboro Plat 2 because: i) the absence of the trail will not adversely affect the public health, safety or general welfare; ii) the existence of incompatible grades along the intended route unduly interferes with its construction; and, iii) the lack of connection facilities for such trail limits its potential utility.
- 2. The City Council hereby releases Jerry's Homes, Inc., from its obligation to construct the recreational trail along the segment of E. Pine Avenue adjoining Hillsboro Plat 2.
- 3. Subdivision Improvement Bond No. IAC 33296 in the amount of \$27,145 from Jerry's Homes, Inc. and Merchant's Bonding Company, is hereby released as security for the satisfactory completion of the subdivision improvements.

Jerry's Homes formally requests that Bond IAC 33296 be released by the City of Des Moines.

The bond was originally required for a 4 foot sidewalk and a section of 10 foot recreational trail that would be installed along E. Pine Ave and is an obligation of our Hillsboro Plat 2.

The 4 foot sidewalk has been completed by Jerry's Homes but The Des Moines Parks and Recreation Department has not constructed nor asked Jerry's Homes to construct the portion of trail included in this bond.
