# APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR STORM AND SANITARY SEWER IMPROVEMENTS, THE WOODS OF COPPER CREEK PLAT 2,

BETWEEN VANDERPOOL CONSTRUCTION, INC. AND HDR LAND DEVELOPMENT, LLC

WHEREAS, on October 7, 2013 under Roll Call No. 13-1542, the City Council approved a private construction contract in the amount of \$296,841.05, between Vanderpool Construction, Inc., Mike Vanderpool, President, 1100 N. 14th Street, Indianola, IA, 50125-1566 - as Contractor, and HDR Land Development, LLC, Larry Handley, Manager, 2575 North Ankeny Boulevard, Ankeny, IA, 50023 - as Owner, for construction of Storm and Sanitary Sewer Improvements described as construction of storm and sanitary sewer improvements to service the proposed The Woods of Copper Creek Plat 2, on N.E. 47th & 48th Streets and Wisconsin Avenue, as per Plan File Nos. 554-057/073, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines Interim City Engineer.


