With mixed feelings, I hereby resign from the Access Advisory Board of the City of Des Moines. Since you appointed me so long ago that my statutory term limit expired June 15, 2010, I've greatly enjoyed my work on the A.A.B. Not only have I made a difference in my community, but I have also valued the people with whom I've worked.

I do not wish to leave the A.A.B., but I must do so for two reasons. First, I have taken a job at the lowa Department for the Blind and I haven't had time recently to attend A.A.B. meetings. While I've participated by phone, I do not feel that Ithis kind of participation fulfills the obligations of my service. Second, a friend of mine, Adam Reynolds, has filed an Application to serve on the A.A.B., and I ask you to appoint him to replace me. He is a person with a disability who lives a few blocks away from me and works at the Science Center. I've known him for years through political and advocacy functions and I know he'll be an asset to the A.A.B. and will greatly contribution to our effort to further extend accessibility in the City.
