RESOLUTION CONTINUING HEARING ON REQUEST FROM 304 15<sup>TH</sup> STREET, LLC (OWNER), REPRESENTED BY JAKE CHRISTENSEN (OFFICER), TO REZONE PROPERTY LOCATED AT 304 15<sup>TH</sup> STREET TO REMOVE THE "D-O" DOWNTOWN OVERLAY DISTRICT DESIGNATION AND REMOVE THE PROHIBITION OF OFF-PREMISES ADVERTISING SIGNS

WHEREAS, on October 20, 2014, by Roll Call No. 14-1629, the City Council received and filed the recommendation from the City Plan and Zoning Commission, by a vote of its members of 7-2-1, to recommend **DENIAL** of a request from 304 15th Street, LLC (owner), represented by Jake Christensen (officer), to rezone property located at 304 15th Street ("Property") to remove the "D-O" Downtown Overlay District and remove the prohibition of off-premises advertising signs, to allow Board of Adjustment consideration of a 30-foot by 30-foot (900 square feet) painted wall sign on the north side of the building located on the Property to advertise for off-premise business Exile Brewing Company, which is located at 1514 Walnut Street; and

**WHEREAS**, on October 20, 2014, by Roll Call No. 14-1629, it was duly resolved by the City Council that the application of 304 15<sup>th</sup> Street, LLC (owner) to rezone the Property, legally described as follows, be set down for hearing on November 3, 2014 at 5:00 p.m. in the Council Chamber at City Hall:

The South 10 feet of Lot 5 and all of Lot 8 of Block 43, LYON'S ADDITION, an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa; and

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said proposed amendment to the Zoning Ordinance; and

WHEREAS, on November 3, 2014, by Roll Call No. 14-1731, City Council opened and continued said hearing to December 8, 2014 at 5:00 P.M., in order for Exile Brewing Company representatives and City staff to continue reviewing alternative options in relation to the proposed signage; and
