**SET HEARING FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY  
ADJOINING 923 EAST RAILROAD AVENUE TO JESSE E. RAMIREZ, FOR \$150**

**WHEREAS**, on August 4, 1997, by Roll Call Number 97-2746, the City Council of the City of Des Moines vacated all of the alley right-of-way in the block located south of E. Railroad Avenue between S.E. 9<sup>th</sup> Street and S.E. 10<sup>th</sup> Street, including the portion of alley right-of-way lying south of and adjoining 923 E. Railroad Avenue (“Property”); and

**WHEREAS**, Jesse E. Ramirez, owner of 923 E. Railroad Avenue, has offered to the City of Des Moines the purchase price of \$150.00 for the purchase of the vacated alley right-of-way adjoining his property for incorporation into the larger residential parcel, which price reflects the fair market value of the Property as currently estimated by the City’s Real Estate Division; and

**WHEREAS**, there is no known current or future public need for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa proposes to sell the vacated alley right-of-way adjoining 923 E. Railroad Avenue, as legally described and to the grantee and for the consideration identified below, subject to reservation of easements therein:

COUNTY, IOWA.

2. A public hearing shall be held on January 12, 2015 at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal and any other(s) submitted prior to or during the public hearing.

3. The City Clerk is hereby authorized and directed to publish notice of said proposal and hearing in the form hereto attached, all in accordance with Section 362.3 of the Iowa Code.

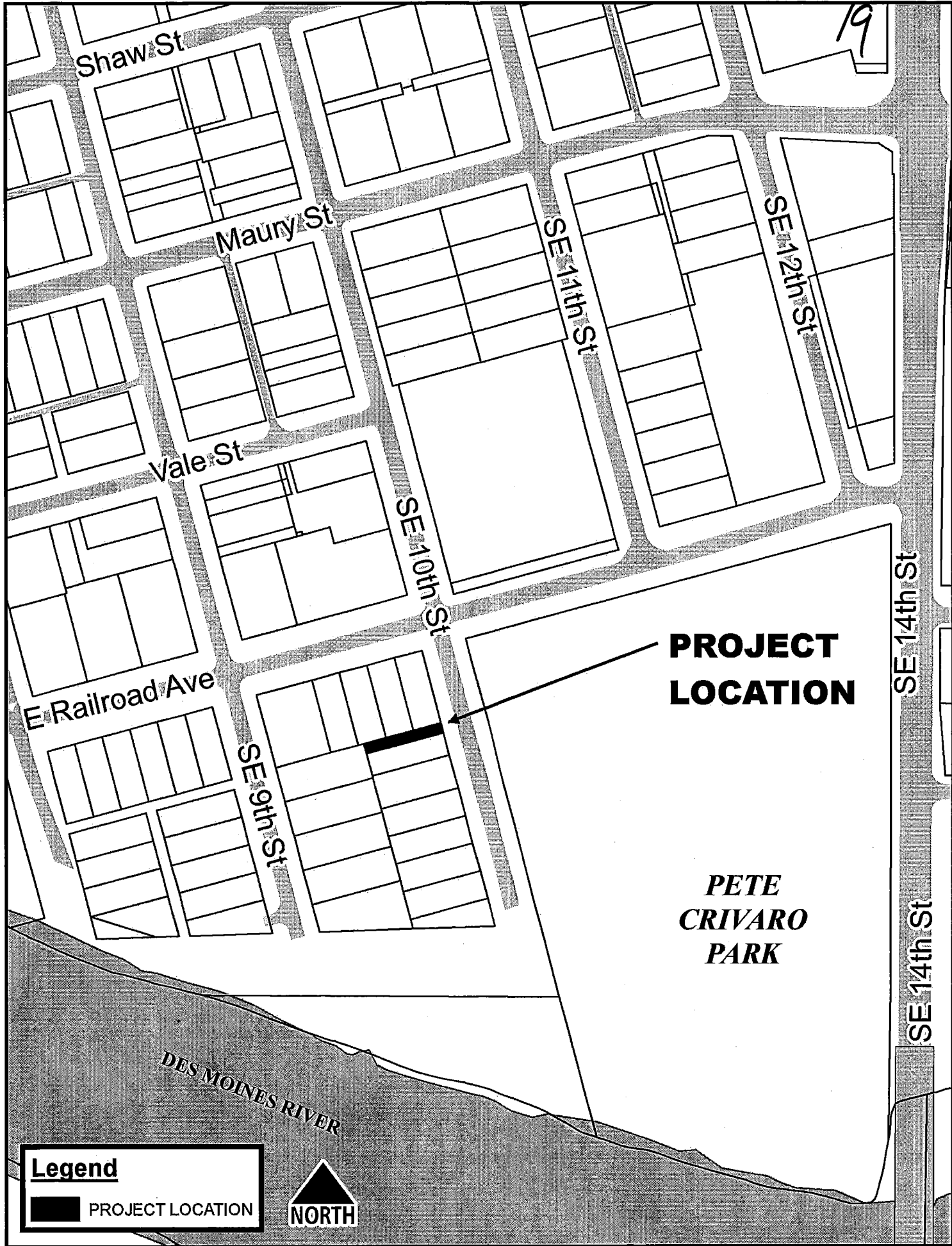
