AUTHORIZING SUBMITTAL OF STP AND TAP FUND FY2019 APPLICATIONS TO THE DES MOINES AREA METROPOLITAN PLANNING ORGANIZATION

WHEREAS, The City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Program (STP) and Transportation Alternatives Program (TAP) provide funding to local jurisdictions for the construction of eligible projects; and also

WHEREAS, the programs are administered by the Des Moines Area MPO that prioritizes and ranks all project applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

That the City Manager is hereby authorized to submit applications to the Metropolitan Planning Organization for Federal Surface Transportation Program (STP) and Transportation Alternatives Program (TAP) funds for the following projects:

STP Project Applications

- 1. <u>Roadway Project</u>: Southeast Connector--SE 30th Street to US 65 Beltway
- 2. <u>Roadway Project</u>: Indianola Avenue Widening—E Army Post Road to US 69
- 3. <u>Bridge Repair/Replacement Project</u>: E 30th Street Viaduct over the Union Pacific Railroad
- 4. <u>Maintenance Project</u>: E 29th Street Resurfacing--Easton Boulevard to E Euclid Avenue
- 5. <u>Flex STP Funds—Planning Studies</u>: Transit Oriented Development Zoning Overlay Regulations

- 6. <u>Streetscape Project</u>: 6th Avenue Streetscape Project, Phase 1
- 7. <u>Streetscape Project</u>: Ingersoll Streetscape, Phase 2
