APPROVING AMENDMENT TO DEVELOPMENT AND COMPLETION AGREEMENT WITH DES MOINES BICYCLE COLLECTIVE RELATED TO THE EXPANSION OF THE DES MOINES B-CYCLE PROGRAM

WHEREAS, on October 20, 2014, by Roll Call No. 14-1664, the City Council approved the Agreement Between the City and The Des Moines Bicycle Collective For Development and Completion of Three Bicycle Sharing Stations ("the Agreement") pursuant to which the Bicycle Collective agreed to develop, complete and maintain the expansion of the Des Moines B-Cycle Program, including funding needed in advance and for the costs of the Three Bicycle Sharing Stations Project, in compliance with the terms of an Iowa Department of Transportation grant awarded to the City for such Project ("the IDOT Agreement"); and

WHEREAS, the IDOT has informed the CITY that the reimbursement process under the IDOT Agreement between the CITY and the IDOT will require the CITY to first reimburse the Des Moines Bicycle Collective for eligible costs for the Project before the CITY may seek reimbursement for such Project costs, and that a 5% retainage will also be withheld from IDOT's reimbursement to the CITY until the project is completed; and

WHEREAS, the Des Moines Bicycle Collective and City staff have agreed to an amendment to the Agreement to clarify that the City will reimburse the Des Moines Bicycle Collective for eligible costs pursuant to the IDOT Agreement and that the City will retain those grant funds which reimburse the City, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The Amendment to Development and Completion Agreement between the City of Des Moines and The Des Moines Bicycle Collective for the expansion of the Des Moines B-Cycle Program, on file in the City Clerk's Office, is hereby approved.
