RESOLUTION ACKNOWLEDGING ASSIGNMENT OF  
ECONOMIC DEVELOPMENT GRANT UNDER FIRST AMENDMENT  
TO URBAN RENEWAL DEVELOPMENT AGREEMENT  
(LIBERTY BUILDING REHABILITATION AND PARKING GARAGE DEVELOPMENT)

WHEREAS, on April 6, 2005, by Roll Call No. 05-814, the City Council of the City of Des Moines approved an Urban Renewal Development Agreement (“Development Agreement”) with Liberty Building Development Group, L.L.C., f/k/a K.C. Holdings VI, L.L.C. (“Liberty”) for the rehabilitation of the Liberty Building located at 418 Sixth Avenue and for the construction of a parking garage at 518 Grand Avenue; and

WHEREAS, on April 12, 2010, by Roll Call No. 10-558, City Council approved a First Amendment to Development Agreement wherein Liberty undertook hotel renovation improvements within the Liberty Building; and

WHEREAS, Liberty and Liberty Building Historic Rehab, LLC have submitted an assignment of the Reduced Economic Development Grant to the City for the assignment of future installments of the Reduced Economic Development Grant under the Development Agreement from Liberty to Liberty Building Historic Rehab, LLC; and

WHEREAS, Liberty and Liberty Building Historic Rehab, LLC have requested the City’s acknowledgement of the assignment; and

WHEREAS, the City’s acknowledgement of the assignment does not constitute an acknowledgement or representation that Liberty or any of its assignees are currently in compliance with the terms and conditions of the Development Agreement or are in compliance with the conditions for entitlement to future installments of the Reduced Economic Development Grant.
