NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The City Clerk is hereby directed to continue to make available a sufficient number of copies of the amendment to the City's annual budget for the current fiscal year ending June 30, 2015 to meet the requests of taxpayers and organizations and to have copies of the amendment to the budget available for distribution at the offices of the Mayor and City Clerk and at the City libraries.
- 2. The public hearing on the amendment to the City's annual budget for the current fiscal year ending June 30, 2015 is hereby fixed and set for the 9th day of March, 2015 at 5:00 o'clock P.M. in the Council Chambers in City Hall, Des Moines, Iowa, at which time any resident or taxpayer of the City may be heard for or against the proposed budget amendment and change.
