That this Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 9th day of March, 2015, for the purpose of taking action on the matter of the issuance of not to exceed \$850,000 General Obligation Bonds, the proceeds of which Bonds will be used to provide funds to pay costs of the improvement, repair and remodeling of City buildings and facilities, including municipal building re-roofing and community center improvements, and shall bear interest at a rate not exceeding the maximum specified in the attached notice.
