SET HEARING FOR CONVEYANCE OF A PERMANENT EASEMENT FOR UNDERGROUND TELECOMMUNICATION LINES AND RELATED UTILITY EQUIPMENT TO CENTURYLINK FOR THE GRAND AVENUE OVER WALNUT CREEK BRIDGE REPLACEMENT PROJECT

WHEREAS, construction of the City's Grand Avenue over Walnut Creek Bridge Replacement Project conflicts with the existing telecommunication lines and related utility equipment owned by Centurylink Corporation, resulting in the need to relocate said telecommunication lines and related utility equipment to a new site on City-owned property; and

WHEREAS, Centurylink Corporation has requested a Permanent Easement for Underground Telecommunication Lines and Related Utility Equipment across City-owned property located north of Grand Avenue and east of 63rd Street for the relocated telecommunication lines and related utility equipment, and the City will not be inconvenienced by the conveyance of said easement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa proposes to establish and grant a permanent telecommunication lines and related utility equipment easement across City-owned property north of Grand Avenue and east of 63rd Street, more specifically described below, to Centurylink Corporation:

A PART OF THE NORTHWEST 1/4 OF THE NORTHEAST 1/4 OF SECTION 11, TOWNSHIP 78 NORTH, RANGE 25 WEST OF THE 5TH P.M., IN THE CITY OF DES MOINES, POLK COUNTY, IOWA AND DESCRIBED AS FOLLOWS:
