RESOLUTION OF SUPPORT FOR A WORKFORCE HOUSING TAX CREDIT BENEFIT APPLICATION TO BE SUBMITTED TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY BY NEIGHBORHOOD DEVELOPMENT CORPORATION, FOR THE MACRAE TERRACE PROJECT IN THE VICINITY OF 2249 SW 9th STREET

WHEREAS, Neighborhood Development Corporation, represented by Glenn Lyons, Executive Director, has requested City support for its application to the Iowa Economic Development Authority ("IEDA") for state tax incentives under the Workforce Housing Tax Credit Program for MacRae Terrace, a 6 unit housing project at 2249 SW 9th Street; and,

WHEREAS, successful completion of the MacRae Terrace project requires funding from a number of sources, including an award of Iowa Workforce Housing Tax Credit Program benefits in the estimated amount of \$112,710.54; and,

WHEREAS, the application requirements for the Workforce Housing Tax Credit program include a requirement for the submission of a resolution in support of the housing project by the community where the housing project will be located, which requirement is intended to be satisfied by this roll call and resolution; and,

WHEREAS, a further application requirement for the Workforce Housing Tax Credit program is documentation of local matching funds pledged for the project in an amount not less than \$1,000 per dwelling unit; and

WHEREAS, the MacRae Terrace project is located within the City-wide Urban Revitalization Area and provided that the project is completed as planned, the taxable value added to the property by the completion of the Improvements will qualify for a temporary exemption from property taxes (a/k/a tax abatement) under the 5-year 100% abatement schedule, providing financial assistance of approximately \$108,468 based upon the estimated annual abated property taxes of \$21,694.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council of the City of Des Moines does hereby express its strong support for the application by Neighborhood Development Corporation, to the IEDA seeking an award of Workforce Housing Tax Credit Program benefits in the amount of \$112,710.54.
- 2. The Mayor and the City Manager are hereby authorized and directed to sign any forms required by the Administrative Rules of the IEDA to evidence the City's support for the

- approval of the same by the City Legal Department.
- 3. The Office of Economic Development is directed to transmit a copy of this resolution and roll call to Neighborhood Development Corporation, for submittal to the IEDA, and to conduct project compliance monitoring.
- 4. In the event that any of the project characteristics mentioned above should change prior to final award of Iowa Workforce Housing Tax Credit Program benefits to Neighborhood Development Corporation, then:
 - a) The City Manager or the City Manager's designee is authorized and directed to execute the applicable consent to any unsubstantial change upon receipt of a recommendation in support of such consent from the Community Development Director.
 - b) Any substantial change shall be subject to approval by the City Council after report and recommendation by the City Manager.
