HOLD HEARING FOR VACATION AND CONVEYANCE OF THE EAST/WEST ALLEY RIGHT-OF-WAY IN THE BLOCK BOUNDED BY FOREST AVENUE, INDIANA AVENUE, $3^{\rm RD}$ STREET AND $4^{\rm TH}$ STREET TO FOREST AVENUE OUTREACH FOR \$150

WHEREAS, on December 8, 2014, by Roll Call No. 14-1887, the City Council referred a request for vacation of the east-west alley right-of-way in the vicinity of 334 Forest Avenue to the Community Development Department and Plan and Zoning Commission for review and recommendation as a City-initiated vacation request; and

WHEREAS, on January 26, 2015, by Roll Call No. 15-0101, City Council adopted a recommendation from the City Plan and Zoning Commission approving a request for the vacation of the east-west alley right-of-way in the vicinity of 334 Forest Avenue, subject to the reservation of easements for all existing utilities in place until such time as they are relocated, and reservation of right of entry for servicing same; and

WHEREAS, Forest Avenue Outreach, owner of 334 Forest Avenue, Ralph Chiodo, II, President, has offered to the City of Des Moines the total purchase price of \$150.00 for the purchase of the vacated alley right-of-way for incorporation into the adjoining property in order to allow for driveway access to the south end of 334 Forest Avenue, which price reflects the fair market value of said vacated alley right-of-way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property; and

WHEREAS, on March 9, 2015, by Roll Call No. 15-0385, it was duly resolved by the City Council that the proposed vacation and conveyance of the City alley right-of-way be set down for hearing on March 23, 2015, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to vacate and convey the City alley right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the City alley right-of-way, as described herein, are hereby overruled and the hearing is closed.

There is no public need or benefit for the alley right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of the east-west alley right-of-way in the vicinity of 334 Forest Avenue, legally described as follows, and said vacation is hereby approved:

- 7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Deed and a copy of the other documents to the grantee.
