## APPROVING AGREEMENT BETWEEN THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY AND THE CITY OF DES MOINES FOR CONSTRUCTION OF THE 2015 LEVEE GATEWELL REPAIR PROJECT

WHEREAS, the annual inspection completed by the US Army Corps of Engineers identified nine (9) gatewell structures in need of repair due to corrosion or other defects, of which seven (7) are owned by the Wastewater Reclamation Authority (WRA) and two (2) are owned by the City of Des Moines(City); and

WHEREAS, the gatewells are located on major sanitary sewers and river crossing siphons. Repair of the gatewells is essential to continue effective operation of the levee system, to protect neighboring properties and to maintain certification of the levee system. Said repairs must be constructed in a manner that allows existing sanitary sewer service to continue while protecting adjoining rivers from any potential leak or spill; and

WHEREAS, the WRA and City have each entered into agreements for professional design services with H.R. Green, Inc., Mr. James Rasmussen, Water President, 5525 Merle Hay Road, Suite 200, Des Moines, Iowa 50131, for the 2015 Levee Levee Gatewell Repairs project to design the needed repairs or replacements for each gatewell owned by the WRA and Des Moines; and

WHEREAS, the WRA and City agree that it is of mutual benefit to each entity to jointly execute construction to repair or replace levee gatewells required to be completed in 2015; and

WHEREAS, the WRA and City have negotiated the terms of this Agreement, providing for construction associated with the 2015 Levee Gatewell Repairs project, which sets forth the terms for replacement or repair of the gatewells and the anticipated allocation for each party's share of construction and construction administration costs. The total estimated project construction and construction administration costs is \$716,769, of which the City's share is \$131,075.
