

AN ORDINANCE vacating a portion of parkland in Pioneer Park and a portion of Pioneer Road right-of-way adjoining Pioneer Park.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated:

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That a portion of parkland in Pioneer Park and a portion of Pioneer Road right-of-way adjoining Pioneer Park, more specifically described as follows, be and is hereby vacated.
