# ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1314.05, 114-1367, 114-2605, 114-2704, 114-3115, 114-3421, 114-3508, 114-3900, 114-3923, 114-3929 and 114-4090, and by repealing Section 114-3866.5, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending

Sections 114-1314.05, 114-1367, 114-2605, 114-2704, 114-3115, 114-3421, 114-3508, 114-3900,

114-3923, 114-3929 and 114-4090, and by repealing Section 114-3866.5, relating to traffic and

vehicle regulations, as follows:

#### Sec. 114-1314.05. Evergreen Avenue.

Evergreen Avenue, from Indianola Avenue to East Marion Street, 30 miles per hour.

Evergreen Avenue, from East Watrous Avenue to Southeast Thirty-fourth Street, 35 miles per hour.

Evergreen Avenue, from Southeast Brooks Drive to Southeast Fortieth Street, 30 miles per hour.

Evergreen Avenue, from Southeast Fortieth Street to Southeast Forty-fifth Street, 40 miles per hour.

#### Sec. 114-1367. East Watrous Avenue.

East Watrous Avenue, from South Union Street to Indianola Avenue, 30 miles per hour. East Watrous Avenue, from Southeast Twenty-fourth Street East Marion Street to Hartford Evergreen Avenue, 35 miles per hour.

#### Sec. 114-2605. Third Street--Walnut Street to Locust Street.

Third Street, on the west side, from Walnut Street to <u>Locust Street</u> a point 130 feet north thereof, no parking any time.

Third Street, on the east side, from Walnut Street to a point 200 feet north thereof, loading zone.

Third Street, on the east side, from a point 200 feet north of Walnut Street to Locust Street, no parking anytime.

#### Sec. 114-2704. Tenth Street--Walnut Street to Locust Street.

Tenth Street, on the west side, from a point 28 feet north of Walnut Street to a point 130 feet north thereof, no parking 7:00 a.m. to 9:00 a.m.

Tenth Street, on the west side, from Locust Street to a point 30 feet south thereof, no parking any time.

Tenth Street, on the west side, from Walnut Street to a point 28 feet north thereof, no parking any time.

Tenth Street, on the east side, from Walnut Street to Locust Street, no parking 4:00 p.m. to 6:00 p.m.

Tenth Street, on the east side, from Walnut Street to a point 185 feet north thereof Locust Street, school passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 4:00 p.m. school days, except on Wednesday, from 7:00 a.m. to 9:00 a.m. and 1:00 p.m. to 3:00 p.m. when school early-out loading and unloading is allowed. An authorized school placard is required to identify vehicles dropping off and picking up during these restricted hours. Twenty-minute limit for all school loading and unloading.

#### Sec. 114-3115. East Court Avenue--Water Street to East Second Street.

East Court Avenue, on the north side, from Water Street to a point 95 feet east thereof, no parking any time.

East Court Avenue, on the north side, from a point 95 feet east of Water Street to a point 45 feet east thereof, loading zone.

East Court Avenue, on the south side, from East First Street to a point 80 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 65 feet west thereof, no parking any time.

East Court Avenue, on the south side, from a point 80 feet west of East First Street to a point 60 feet west thereof, reserved for city of Des Moines municipal employee permit parking and are designated handicapped parking spaces, subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Court Avenue, on the south side, from a point 140 feet west of East First Street to a point 235 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the north side, from a point 65 feet west of East First Street to a point 240 feet west thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Court Avenue, on the south side, from East First Street to a point 35 feet east thereof, no parking any time.

East Court Avenue, on the south side, from a point 35 feet east of East First Street to a point 45 feet east thereof, loading zone, 20 minute limit.

East Court Avenue, on the south side of the street, from a point 80 feet east of East First Street to a point 50 feet west of East Second Street, back-in angle parking only, parking reserved for official police vehicles only.

East Court Avenue, on the north side, from a point 120 feet east of East First Street to a point 90 feet east thereof, loading zone.

East Court Avenue, on the south side, from East Second Street to a point 50 feet west thereof, no parking any time.

East Court Avenue, on the north side, from East First Street to a point 120 feet east thereof, marked police vehicle parking only.

East Court Avenue, on the north side, from a point 210 feet east of East First Street to East Second Street, marked police vehicle parking only.

## Sec. 114-3421. Locust Street--Third Street to Fourth Street.

Locust Street, on the south side, from Third Street to a point 115 feet west thereof, no parking any time.

Locust Street, on the south side, from a point 230 feet west of Third Street to Fourth Street, no parking any time.

Locust Street, on the south side, from a point 115 feet west of Third Street to Fourth Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Locust Street, on the north side, from Third Street to a point 50 feet west thereof, commercial loading zone.

### Sec. 114-3508. Mulberry Street--Ninth Street to Tenth Street.

Mulberry Street, on the north side, from Tenth Street to a point-<u>19\_25</u> feet east thereof, no parking any time.

Mulberry Street, on the north side, from Ninth Street to a point 15 feet west thereof, no parking any time.

Mulberry Street, on the north side, from a point 125 feet west of Ninth Street, to a point-15 100 feet west thereof, no parking any time.

Mulberry Street, on the south side, from Ninth Street to a point 30 feet west thereof, no parking any time.

<u>Mulberry Street, on the south side, from Tenth Street to a point 15 feet east thereof, no</u> parking any time.

Mulberry Street, on the south side, from a point 80 feet east of Tenth Street, to a point 85 feet east thereof, no parking any time.

## Sec. 114-3866.5. Third Street-Walnut Street to Locust Street Repealed by Ord. No. 15,---.

#### Sec. 114-3900. Tenth Street--Walnut Street to Locust Street.

Tenth Street, on the west side, from a point 30 feet south of Locust Street to a point 158 feet north of Walnut Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the west side, from a point 28 feet north of Walnut Street to a point 130 feet north thereof, four-hour meters, 9:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 185 feet north of Walnut Street to Locust Street, four-hour meters, 8:00 a.m. to 4:00 p.m., school loading and unloading weekdays from 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m., except on Wednesday, from 7:00 a.m. to 9:00 a.m. and 1:00

p.m. to 3:00 p.m. when school early-out loading and unloading is allowed. An authorized school placard is required to identify vehicles dropping off and picking up during these restricted hours. Twenty-minute limit for all school loading and unloading.

## Sec. 114-3923. Locust Street--Third Street to Fourth Street.

Locust Street, on the south side, from a point 115 feet west of Third Street to <u>a point 115 feet</u> west thereof Fourth Street, two-hour meters, 98:00 a.m. to 46:00 p.m.

Locust Street, on the north side, from a point 50 feet west of Third Street to Fourth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

### Sec. 114-3929. Mulberry Street--Ninth Street to Tenth Street.

Mulberry Street, on the north side, from a point 15 feet west of Ninth Street to a point 110 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the north side, from a point  $\underline{1925}$  feet east of Tenth Street to a point  $\underline{50}$  feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, from a point 30 feet west of Ninth Street to a point 100 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, from <u>a point 15 feet east of</u> Tenth Street to a point-<u>105</u><u>65</u> feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

## Sec. 114-4090. East Court Avenue--Water Street to East First Street.

East Court Avenue, on the south side, from Water Street to a point 330 feet west of East First Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Court Avenue, on the north side, from <u>a point 140 feet east of</u> Water Street to a point 305 feet west of East First Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
