ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2622, 114-2774, 114-2907, 114-3268, 114-3269, 114-3583, 114-4002, 114-4041, 114-4081, 114-4097 and 114-4098, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending

Sections 114-2622, 114-2774, 114-2907, 114-3268, 114-3269, 114-3583, 114-4002, 114-4041, 114-

4081, 114-4097 and 114-4098, relating to traffic and vehicle regulations, as follows:

Sec. 114-2622. East Fourth Street--East Vine Street to Maple Street.

East Fourth Street, on the east side, from East Vine Street to East Court Avenue, no parking any time.

East Fourth Street, on the west side, from East Walnut Street to a point 220 feet south thereof, no parking any time.

East Fourth Street, on the west side, from East Walnut Street to a point 50 feet north thereof, no parking any time.

East Fourth Street, on the west side, from East Locust Street to a point 30 feet north thereof, no parking any time.

East Fourth Street, on the west side, from a point 100 feet north of East Locust Street to a point 40 feet north thereof, commercial loading zone.

East Fourth Street, on the west side, from East Grand Avenue to a point 25 feet south thereof, no parking any time.

East Fourth Street, on the east side, from East Locust Street to a point 25 feet north thereof, no parking any time.

East Fourth Street, on the east side, from a point 115 feet north of East Locust Street to East Grand Avenue, no parking any time.

East Fourth Street, on both sides, from a point 50 feet north of East Grand Avenue to a point 50 feet south thereof, no parking any time.

East Fourth Street, on both sides, from a point 50 feet south of Des Moines Street to Des Moines Street, no parking any time.

East Fourth Street, on the east side, from Des Moines Street to a point 50 feet north thereof, no parking any time.

East Fourth Street, on the east side, from a point 200 feet north of Des Moines Street to a point 90 feet north thereof, no parking any time.

East Fourth Street, on the west side, from Des Moines Street to Maple Street, no parking any time.

Sec. 114-2774. Seventeenth Street--Locust Street to Ingersoll Avenue.

Seventeenth Street, on the west side, from Locust Street to a point 95 feet north thereof, no parking any time.

Seventeenth Street, on the west side, from Grand Avenue to a point 95 feet south thereof, no parking any time.

Seventeenth Street, on the east side, from Locust Street to a point 65 feet north thereof, no parking any time.

Seventeenth Street, on the east side, from <u>a point 30 feet south of</u> Grand Avenue to Ingersoll Avenue, no parking any time.

Seventeenth Street, on the west side, from Grand Avenue to a point 145 feet south of Ingersoll Avenue, no parking any time.

Seventeenth Street, on the west side, from Ingersoll Avenue to a point 45 feet south thereof, no parking any time.

Seventeenth Street, on the west side, from a point 45 feet south of Ingersoll Avenue to a point 100 feet south thereof, no parking 7:00 a.m. to 9:00 a.m.

Sec. 114-2907. East Thirty-eighth Street--East University Avenue to north city limits.

East Thirty-eighth Street, on both sides, from Avenue Frederick M. Hubbell to a point 75 feet south of East Douglas Avenue, no parking any time.

East Thirty-eighth Street, on the east side, from East Douglas Avenue to a point 75 feet south thereof, no parking any time.

East Thirty-eighth Street, on the east side, from East Sheridan Avenue to a point 100 feet south thereof, no parking any time.

East Thirty-eighth Street, on the west side, from East University Avenue to a point 50 feet north thereof, no parking any time.

East Thirty-eighth Street, on the west side, from East University Avenue Mahaska Avenue to East Washington Avenue, no parking any time.

East Thirty-eighth Street, on the east side, from East University Avenue to a point 50 feet north thereof Mahaska Avenue, no parking any time.

East Thirty-eighth Street, on the east side, from East Jefferson Avenue to Easton Boulevard, no parking any time.

East Thirty-eighth Street, on the east side, from Easton Boulevard to a point 100 feet north thereof, no parking any time.

East Thirty-eighth Street, on the west side, from Easton Boulevard to East Sheridan Avenue, no parking any time.

East Thirty-eighth Street, on the east side, from East Ovid Avenue to a point 50 feet south thereof, no parking any time.

East Thirty-eighth Street, on both sides, from Avenue Frederick M. Hubbell to East Broadway Avenue, no parking any time.

Sec. 114-3268. East Grand Avenue--Des Moines River Bridge to East Fourth Street.

East Grand Avenue, on the north side, from the Des Moines River Bridge to Robert D Ray Drive, no parking any time.

East Grand Avenue, on the north side, from Robert D Ray Drive to a point 320 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the north side, from a point 320 feet east of Robert D Ray Drive to a point 185 feet east thereof, no parking any time.

East Grand Avenue, on the north side, from a point 195 feet east of Robert D Ray Drive to a point 120 feet east thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from Robert D Ray Drive to a point 45 feet west thereof, no parking any time.

East Grand Avenue, on the south side, from a point 45 feet east of Robert D Ray Drive to a point 300 feet east thereof, reserved for city of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

East Grand Avenue, on the south side, from East Second Street to a point 20 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 223 feet east of East Second Street to a point 63 feet east thereof, no parking any time.

East Grand Avenue, on the north side, from a point 135 feet west of East Fourth Street to a point 260 feet west thereof, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Grand Avenue, on the north side, from East Fourth Street to a point 20 feet west thereof, no parking any time.

East Grand Avenue, on the south side, from a point 20 feet west of East Fourth Street to a point 40 feet west thereof, loading zone.

East Grand Avenue, on the south side, from East Fourth Street to a point 20 feet west thereof, no parking any time.

Sec. 114-3269. East Grand Avenue--East Fourth Street to East Fifth Street.

East Grand Avenue, on both sides the north side, from East Fifth Street to a point 75 feet west thereof, no parking any time.

East Grand Avenue, on the south side, from a point 360 feet east of East Fourth Street to a point 25 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 305 feet east of East Fourth Street to a point 15 feet west thereof, no parking any time.

East Grand Avenue, on the north side, from a point 240 feet east of East Fourth Street to a point 50 feet east thereof, commercial loading zone.

East Grand Avenue, on the south side, from a point <u>175</u><u>80</u> feet east of East Fourth Street to a point <u>75</u><u>175</u> feet east thereof, no parking any time.

East Grand Avenue, on the south side, from East Fourth Street to a point 20 feet east thereof, no parking any time.

Sec. 114-3583. East Porter Avenue--South Union Street to Southeast Thirty-second Street.

East Porter Avenue, on the north side, from Southeast Fifth Street to a point 250 feet east thereof, no parking any time.

East Porter Avenue, on the north side, from the west curb line of Southeast Eighth Street to a point 230 feet west thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

East Porter Avenue, on the north side, from the west curb line of Southeast Eighth Street to a point 55 feet east thereof, no stopping, no standing, 7:00 a.m. to 5:00 p.m. school days.

East Porter Avenue, on the north side, from Indianola Avenue to Southeast 24th Street, no parking any time.

East Porter Avenue, on the south side, from the dead end west of East Cutler Avenue to Southeast Thirty-second Street, no parking any time.

Sec. 114-4002. Seventeenth Street--Locust Street to Grand Avenue.

Seventeenth Street, on the east side, from a point 65 feet north of Locust Street to <u>a point 30</u> feet south of Grand Avenue, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Seventeenth Street, on the west side, from a point 95 feet north of Locust Street to a point 95 feet south of Grand Avenue, four-hour meters, 9:00 a.m. to 6:00 p.m.

Sec. 114-4041. Walnut Street--Fifteenth Street to Sixteenth Street.

Walnut Street, on the north side, from a point 15 feet west of Fifteenth Street to a point 60 feet west thereof, three-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from a point 20 feet west of Fifteenth Street to a point 45 feet west thereof, three-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, parking meter W-1518, is designated as handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Walnut Street, on the south side, from a point 20 feet east of Sixteenth Street to a point 180 feet east thereof, three-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4081. East Fourth Street--East Walnut Street to Des Moines Street.

East Fourth Street, on the west side, from a point 50 feet north of East Walnut Street to East Locust Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from East Walnut Street to East Locust Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, parking meter E4-322, ten-hour meter, is designated as a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Fourth Street, on the west side, from <u>a point 30 feet north of</u> East Locust Street to a point <u>50 70</u> feet-south north thereof-of East Grand Avenue, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east west side, from <u>a point 140 feet north of East Locust Street to a</u> point 140 feet north thereof 25 feet south of East Grand Avenue, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from a point 25 feet north of East Locust Street to a point 90 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the west side, from a point fifty feet north of East Grand Avenue to a point 50 feet south of Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fourth Street, on the east side, from a point fifty feet north of East Grand Avenue to a point 50 feet south of Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4097. East Grand Avenue--Des Moines River Bridge to East Fourth Street.

East Grand Avenue, on the south side, from Des Moines River Bridge to a point 45 feet west of Robert D Ray Drive, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 45 feet west of Robert D. Ray Drive to a point 55 feet west thereof, parking meters EG-007a and EG-007b, two-hour meters, 8:00 a.m. to 6:00 p.m., are designated handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Grand Avenue, on the north side, from East Fourth Street to a point 505 feet east of Robert D Ray Drive, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side from a point 240 feet east of Robert D Ray Drive to a point 65 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 20 feet east of East Second Street to a point 180 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 290 feet east of East Second Street to a point <u>62.20</u> feet west of East Fourth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 20 feet east of East Fourth Street to a point 60 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 255 feet east of East Fourth Street to a point 50 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 320 feet east of East Fourth Street to a point 40 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4098. East Grand Avenue--East Fourth Street to East Fifth Street.

East Grand Avenue, on the north side, from <u>a point 25 feet east of</u> East Fourth Street to a point <u>240 215</u> feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the north side, from a point 290 feet east of East Fourth Street to a point 75 feet west of East Fifth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from East Fourth Street to a point 175 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 250 feet east of East Fourth Street to a point 75 feet west of East Fifth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
