SET HEARING FOR THE VACATION AND CONVEYANCE OF A SEGMENT OF MARTIN LUTHER KING, JR. PARKWAY (FORMERLY ELM STREET) ADJOINING 300 WEST MARTIN LUTHER KING, JR. PARKWAY TO GREEN LTD., L.C. FOR \$9,090.00

WHEREAS, on May 18, 2015, by Roll Call No. 15-0806, City Council received a recommendation from the City Plan and Zoning Commission that the segment of West Martin Luther King, Jr. Parkway (formerly Elm Street), hereinafter more fully described, be vacated, subject to reservation of easements for all existing utilities in place, including known water and sanitary sewer mains, until such time that they are abandoned or relocated; and

WHEREAS, Green Ltd., L.C., owner of 300 West Martin Luther King, Jr. Parkway, has offered to the City of Des Moines the purchase price of \$9,090.00 for the vacation and purchase of the West Martin Luther King, Jr. Parkway (formerly Elm Street) right-of-way adjoining 300 West Martin Luther King, Jr. Parkway (herein "City Right-of-Way"), for site edge improvements along West Martin Luther King, Jr. Parkway as part of the redevelopment of their adjoining property, which price reflects the fair market value of the City Right-of-Way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the portion of the City Right-of-Way proposed to be vacated, or for the City Right-of-Way proposed to be sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a segment of West Martin Luther King, Jr. Parkway (formerly Elm Street) adjoining 300 West Martin Luther King, Jr. Parkway, legally described as follows:

THE SOUTH 10 FEET OF WEST MARTIN LUTHER KING JR PARKWAY RIGHT OF WAY LYING NORTH OF AND ADJOINING LOT 1, GREEN COLONIAL PLACE PLAT TWO, AN OFFICIAL PLAT, SAID RIGHT OF WAY ALSO KNOWN AS ELM STREET RIGHT OF WAY, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APROXIMATELY 3637 SQUARE FEET.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines further proposes to sell such vacated right-of-way, as legally described below, to Green Ltd., L.C. for \$9,090.00, subject to the requirements of the Plan and Zoning Commission recommendation:

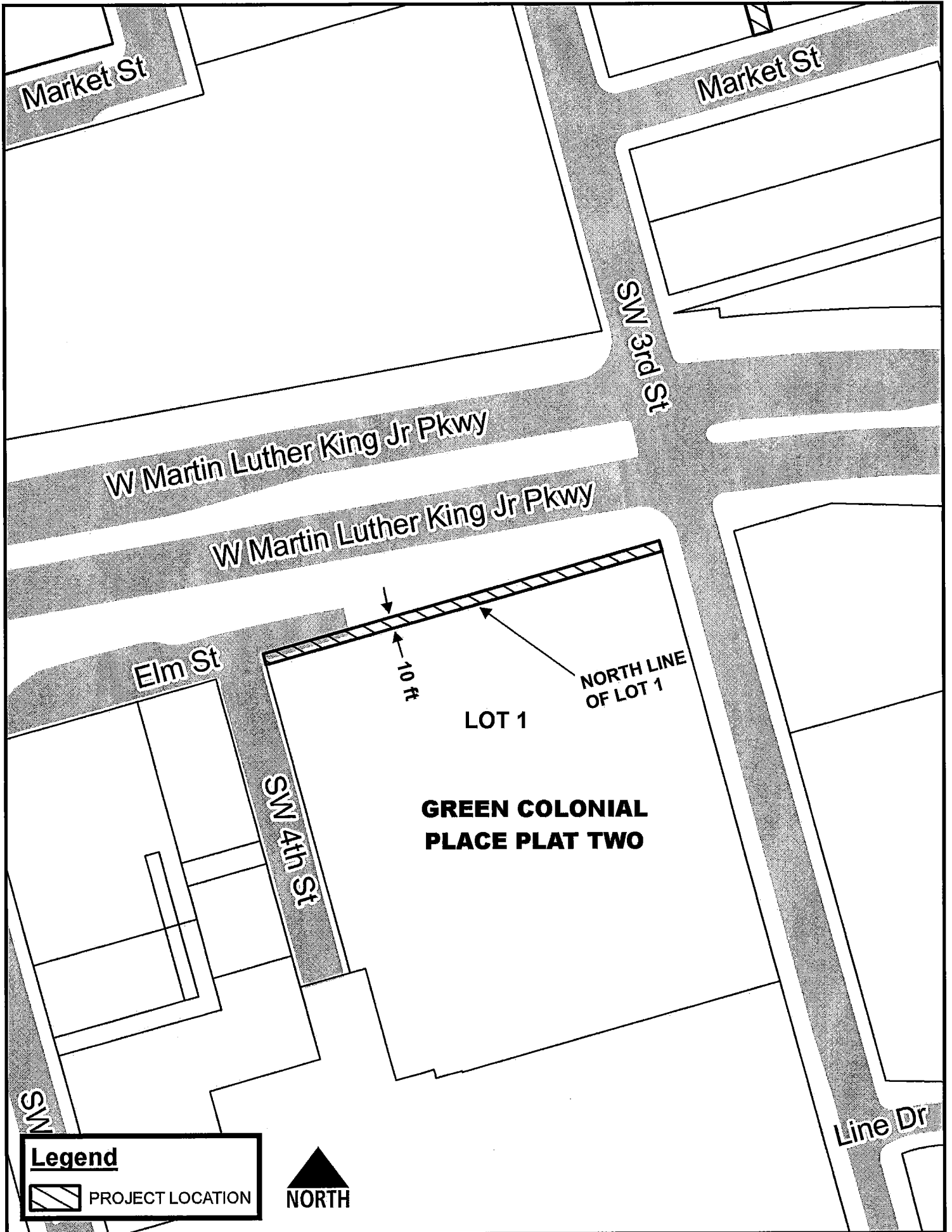
