COMMUNICATION FROM THE CITY MANAGER REGARDING DEVELOPMENT OF THE CITY-OWNED PARKING LOT EAST OF CITY HALL

WHEREAS, the City of Des Moines owns the surface parking lot east of City Hall, bordered by East Grand Avenue, East Locust Street, and East Second Street, and currently used for City employee parking and leased to Embassy Suites for parking purposes; and

WHEREAS, this City-owned site serves as a key connector between the East Village neighborhood and commercial activity and the Riverwalk and western downtown area; and

WHEREAS, 219 East Grand, LLC (Jake Christensen and Tim Rypma, officers and Jim Cownie, principal investor) have contacted City staff regarding a phased development proposal for the City-owned parking lot, which may include housing, retail, and office components, and structured parking for current and planned redevelopment needs; and

WHEREAS, on May 4, 2015, by Roll Call No. 15-0770, City Council received and filed a communication from the City Manager regarding development of the City-owned parking lot east of City Hall, and referred the item to the City Manager for additional information regarding the developer selection process for the site; and

WHEREAS, on May 18, 2015, by Roll Call No. 15-0870, City Council received and filed a communication from the City Manager setting forth the process for selecting a developer and development process for the site; and

WHEREAS, in accordance with said Council direction, City staff solicited additional interest in the site based on a variety of criteria, including creation of connectivity in downtown and providing appropriate context with City Hall and East Village, and requested additional proposals from any other interested developers by June 12, 2015; and

WHEREAS, no additional proposals were received in response to the staff solicitation described above, and the City Manager's Office continues to recommend working with 219 East Grand, LLC to further define the development proposal and to negotiate preliminary terms of agreement.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa:
