Des Moines Cold Storage, a family owned company established in 1910, owns and operates five, USDA approved, cold storage warehouses in Iowa, totaling 474,000 sq. ft. of space. We have over 500 customers and provide storage for meat, vegetables, seafood, frozen meals and juices. We also provide value added services such as specialized boxing, order picking and export processing via rail or truck.
